Sir,
In producing herewith one accused person named Biswajit Barman @ Babu (M-39) S/o Lt. Sarbananda Barman of Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure. One white colour nylon bag containing 02 (two) paper made cartoon each cartoon containing 20 (twenty) bottles i.e. (20X2=40 bottles) of "HIMALAYAN GOLD" 60 UP India made liquor each bottle containing 600 ml. i.e. (600 ml X 40 = 24 Liters) marked as "Exhibit-A" out of which 02 bottles taken from each cartoon for examination and marked as "Exhibit-A1" and "Exhibit-A2".

I, ASI Biplab Kumar Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Biswajit Barman @ Babu (M-39) S/o Lt. Sarbananda Barman of Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling to the effect that today on 01.03.2026 while performing special mobile duty at around 17.05 hrs I received a specific source information that one person would be coming to Siliguri Junction near Heritage Hotel with huge quantity of illegal liquor without any valid documents to deliver the same to his design customer for his wrongfull gain. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 32 dated 01.03.2026 and informed the fact to you. Accordingly, as per your kind order and direction myself along with ASI Prabal Sarkar, C/1119 Tanmoy Roy all for Pradhan Nagar PS left for Siliguri Junction by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Siliguri Junction, I contacted with one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over telephone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling to videograph the entire process of search and seizure if required. At around 21.05 hrs. on 01.03.2026 we arrived at Siliguri Junction near Heritage Hotel and contacted with my source while he stated that the person possessing illegal liquore will come to Siliguri Junction near Heritage Hotel within a short period of time. Then, I contacted with two independent witnesses namely (i) Binay Mondal (M-56) S/o Lt. Ram Chandra Mondal of Boarding Para, W/No. 7, P.S. Dinhata, Dist. Coochbehar, and ii) Raja Sahani (26 yts); S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and and requested them to remain present at the spot and act as witness upon which they agreed. At around 21.15 hrs on 01.03.2026 we noticed that one person with a whilte colour nylon bag in his possession came to Siliguri Junction near Heritage Hotel. Being pointed by the source, I cordoned the place from every corner with due care and caution and managed to detain him with a whilte colour nylon bag in his possesson. On interrogation the detained person disclosed his name and identity as noted above and on further interrogation he disclosed that there are total 40 bottles of Himalayan Gold 60 UP liquor containing 02 paper made cartoon inside the nylon bag in his possession. Further being searched of the whilte colour nyulon bag under the possession of the said accused person Biswajit Barman @ Babu (M-39) S/o Lt. Sarbananda Barman of Dakshin Palash; P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling recovered 40 bottles 60 UP ID liquor which were kept inside two separate paper made cartoons. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he collected the said Siliguri Junciton to sale the same to his design customers. On further grilling, he confessed his guilt and stated that he procured the said quantities of ID liquor clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers for his wrongfull gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned detained person namely Biswajit Barman @ Babu (M-39) S/o Lt. Sarbananda Barman of Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling after observing all formalities of arrest, informing him regarding the ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. The entire process of seizure and label has been made in between 21.55 hrs. to 22.25 hrs on 01.03.2026 at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS.

I therefore pray before your good self that a specific case may kindly be initiated against accused person namely Biswajit Barman @ Babu (M-39) S/o Lt. Sarbananda Barman of Dakshin Palash, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
