Subject: Complaint for Registration of FIR

Respected Sir,

I, Nikhil Kumar Singh, S/o Abhay Kumar Singh, resident of Sukanto Pally, Ward No. 32, P.S. NJP, P.O. Siliguri Bazar, District Jalpaiguri, hereby submit this written complaint seeking immediate registration of an FIR and strict legal action against the accused persons.

On 27.02.2026 the at around 10:10 PM to 10:30 PM, while I was returning home after closing my shop I reached Jalpaimore and having Tea with my friends Prashant Roy, s/o Arun Kumar, Ayushman Aka s/o Kouleswar Sah, Nilotpal Sarkar, s/o Ranigopal Sarkar at Tania Coffe Centre, Jalpaimore. Suddenly approximately 10-15 persons, including MD Tarik Ansari (M No :- 8972174863) residing at Fulbari attacked on me without any notice and beaten me with belt, rod and helmets > Among them One of his friends showing sharp knife and threaten me if I informed to the police, they kill me. During the assault, they forcibly had taken approx ₹25,000/- in cash from my pocket.

Thereafter, I immediately went to the Government Medical Hospital for medical treatment. Medical records can be produced as evidence.

In the earlier on 23rd February 2026 at approximately 4:30 PM, Md. Tarik Ansari, (M no. 8972174863) along with 10-12 unidentified associates, unlawfully entered my showroom at Planet Mall, Sevoke Road, Shop No - 18,19 and demanded protection money (extortion). Upon my refusal, he criminally intimidated me and openly threatened to kill me.

So, I therefore lodge FIR against Md Tarik Ansari along with 10 to 12 person and take necessary action as early as possible.
