With due respect, I Smt. Jhunki Roy, Wife of Raju Roy, Resident of Seema Sarani, Haiderpara, Ward No. 39 of SMC, Dist:- Jalpaiguri, do hereby inform you that, at around 12:30 pm, some person namely Pradip Chowdhury, s/o. Monohari Chowdhury, Babu Chowdhury, s/o. Pradip Chowdhury, Piku Chowdhury, s/o. Pradip Chowdhury and some other unknown goons entered in my house premises and started an hot altercation with abusive language and thereafter they physically assaulted my husband, regarding a property dispute which is pending in Jalpaiguri court, they threatened to withdraw the case purpoting upon such they assaulted my husband, upon protesting the above named persons assaulted me as well by touching and pushing in my chest. They snatched one gold chain from me forcefully, upon such my husband protested against the sudden incident occurred in my premises. While, they successful flee, i somehow noted the vehicle no. being WB 74 AS 9151, an Red colour car.
