In producing herewith one arrested accused person, namely Sushen Roy (51) s/o Hareklal Roy of Fakdaibari, PO- Goghomali, PS- Bhaktinagar, Dist- Jalpaiguri, along with the following articles under proper seizure list: -

[1] 20 (Twenty) sealed bottles of "HIMALAYAN GOLD 60 UP PET India Made Liquor each bottle containing 600 ml, i.e. 600*20=12,000 ml, having M.R.P. of Rs. 170/-, i.e. 170*20= 3400/-, blended and bottled by Himalayan Endeavour Pvt. Ltd and is marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample for examination and marked as "Exhibit-A-1".

I, ASI Madhusudan Barman, s/o Taranikanta Barman of Ashighar OP, under Bhaktinagar Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted arrested accused person, Sushen Roy, to the effect that today, 28/02/2026, at 19:05 hrs, I received reliable source information regarding the unauthorized storage and sale of illicit liquor at a house in Fokdaibari, under Bhaktinagar PS, Dist. Jalpaiguri. This information was duly recorded in the General Diary of Ashighar OP GDE No. 936, dated 28/02/2026 and shared with the Officer-in-Charge. Following his instructions, I led a team to Fokdaibari to verify the veracity of source information, arriving at approximately 19:20 hrs. Upon identification by the source, we conducted a raid at the house of Sushen Roy and detained him. During interrogation, he disclosed his identity and admitted to storing and selling illicit liquor without a valid license for personal gain over the past few months. A search of the premises led to the recovery of the seized articles, for which he failed to produce any legal documentation or permits. Consequently, I seized and labeled the liquor under a proper seizure list between 19:30 hrs and 19:37 hrs, documented the process via videography, and arrested the accused after completing all necessary legal formalities on-site and informed him of his ground of arrest.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person Sushen Roy (51) s/o Hareklal Roy of Fokdaibari, PO- Goghomali, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
