In producing herewith arrested accused person namely Manoj Singh (50) S/O Late Sunil Singh of South Colony, Pachkalguri, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 12 (twelve) bottles of Himalayan Gold, 60 UP, Country Spirit. Each bottle containing 600 ml in sealed condition.

I, SI Tanmoy Kundu, presently attached with NJP PS under your kind control beg to state that today i.e. on 28/02/2026, at about 17:05 hrs I received a secret source information that one person namely Manoj Singh (50) S/O Late Sunil Singh of South Colony, Pachkalguri, P.S. - New Jalpaiguri is selling ID liquor illegally at South Colony main road, in front of Central School, under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 1371 dated 28/02/2026 and informed the fact to you. As per your kind direction and instruction myself along with SI Binup Mahato, VP/08 Laxman Roy, C/1462 Sajjan Tamang left for South Colony main road, in front of Central School to work out the information in hand. At about 18:45 hrs we arrived at South Colony, main road in front of Central School and on being shown and identified by the source we found that above noted person is selling Country Spirit illegally there. We managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor in such way since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/license in respect of such selling of I/D liquor. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest. Ground of Arrest duly been communicated to him. The whole process of search, seizure & arrest was made in between 18:50 hrs 19:10 hrs on 28/02/2026.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Manoj Singh (50) S/O Late Sunil Singh of South Colony, Pachkalguri, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
