Sir,

With due respect I am producing herewith one (01) arrested accused person namely Bivas Dutta @ Nontai (36/M) s/o Late Subhas Dutta of Bhuttabari, PS- NJP dist Jalpaiguri under proper arrest memo along with following seized articles -

- i) One ladies bicycle styled as Magma Nora bearing body No- SK 22B7 9049.
- ii) Eight (08) No's of bicycle in different colours, different types and different brands

I SI Tanmoy Kundu presently attached with NJP PS, Siliguri Police Commissionerate under your kind control beg to state that today on 01/03/2026 I received a secret source information that one person is standing at Railway Hospital More with one ladies bicycle for its disposal, Accordingly I informed the matter to you and noted in GDE vide NJ.P PS GDE No 35 Dated 01/03/2026 and I along with ASI Nilam Swarnakar, C/453 Uttam Dey, C/1462 Sajan Tamang, VP 13 Jamirul Islam, VP/08 Laxman Roy left for Railway Hospital More for verify the matter. After reaching Railway Hospital More I found the above noted person was standing there with one ladies bicycle. After seeing the police party the above noted person tries to flee away from the spot but somehow we managed to detain him. On being asked the apprehended person disclosed his name and address mentioned above and admitted that the bicycle is stolen article and he was there to deliver the same to designed customer for his wrong full gain. On asked, he failed to produce any papers in support of carrying the said bicycle. It is crystal clear and reason to believe that the above noted accused person carrying the bicycle by illegal means or by stolen means for dishonestly dispose the same to earn huge money illegally.


Accordingly, I seized the above noted ladies bicycle from his possession under proper seizure list and arrested him under proper memo of arrest after observing all the formalities of arrest as well as ground of arrest is duly communicated with him. Further as per the leads I along with force and the above noted accused person namely Bivas Dutta @ Nontai had been to his residence i.e. at Bhuttabari under NJP PS and further we recovered above noted Eight (08) No's of bicycle in different colors and different types and different brands from his residence. On asked, he failed to produce any papers in support of the above bicycles and I seized the same under proper list. The whole process of seizure and arrest was made in between 18.55 hrs to 19.35 hrs on 01.03.2026.

Hence, I pray to you considering the offence the specific case may kindly be started against the arrested accused person namely Bivas Dutta @ Nontai (36/M) s/o Late Subhas Dutta of Bhuttabari, PS- NJP dist Jalpaiguri under proper section of law and arrange for its investigation.
