Sir,

In producing herewith one accused person named ,Manoj Lama @ dawa (41) S/O Gopi Lama Of Gitalpara, W/N 40, PS Bhaktinagar Dist Jalpaiguri under arrest along with following seized articles viz,

- 17 (seventeen) bottles of Himalayan Gold 60 up country Spirit (each bottle containing 600 ml, total 10.200 ml.) Cost rs- 170/Marked as exhibit "A"
- 30 (Thirty) bottles of 70 up kachhi each bottles containing 300 ml, cost rs -40/,each marked as exhibit "B". (each bottle containing 300ml, total 09.000 ml.)
- One White colour nylon bag marked as exhibit "C".

I, ASI Dhruba Misra of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against above noted person to the effect that today on 02.03.2026 at about 15.15 hrs received a source information that one person is storing and selling liquor at his house located at Gitalpara, W/N 40, Ps Bhaktinagar, Dist Jalpaiguri without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with ASI Khagen Barman, ASI Dipak Karmakar and C/ 374 Debraj Biswas had been to Gitalpara, W/N 40, PS Bhaktinagar Dist Jalpaiguri PS to verify the veracity of source information.

At 15.30 hrs we reached there and as identified by the source I found one person was selling illicit liquor at his house located at Gitalpara, W/N 40, PS Bhaktinagar Dist Jalpaiguri Subsequently, I along with other officer and force cordoned the area and detained the above noted person. Subsequently on being asked the person disclosed his name and identity as noted above.

Further being searched the above noted seized articles was found at his home. On demand he failed to produce any valid license/papers for selling of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and arrested the above mentioned person named Manoj Lama @ dawa (41) S/O Gopi Lama Of Gitalpara, W/N 40, PS Bhaktinagar Dist Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure & Label has been made in between 15:45hrs to 16.45 hrs at the spot and arrested him after informing the ground of arrest. The entire seizure was captured in audio video record.

I, therefore pray before your good self that a specific case may kindly be initiated against Manoj Lama @ dawa (41) S/O Gopi Lama Of Gitalpara, W/N 40, PS Bhaktinagar Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
