**Subject: Complaint regarding theft at Gem House building**

Respected Sir/Madam,

I would like to lodge a formal complaint regarding a theft that occurred at our building, **Gem House**, situated at 2nd Mile, Sevoke Road, beside Uttar Banga Marwari Bhawan, Siliguri – 734001.

The incident took place on Saturday night (21-02-2026). However, we came to know about the matter only on Monday morning, as all the offices in the building remained closed on Sunday. Upon opening the premises and conducting a preliminary inspection, we noticed that certain materials had been stolen.

It has been found that **copper pipes from the outlet lines of approximately 8 (eight) air conditioners installed on the terrace have been stolen**. There may be additional losses, but as per our current assessment, copper pipes from at least 8 air conditioning units have been removed.

Further, **electric wires from the 3rd floor and 1st floor** of the building have also been cut and stolen by unknown person(s).


The theft has resulted in financial loss to the building owners and has disrupted normal functioning. It appears that the incident occurred during the night hours when the premises were unattended.

I, **Rajeev Jaiswal**, an employee of Gem House, am submitting this complaint on behalf of the Building Committee of **Sevoke Road Gem's Byabasayee Owners Welfare Association**. We request you to kindly treat this as a formal complaint, register the same, and take necessary legal action. We also request you to conduct a thorough investigation to identify the persons responsible and help us recover the stolen materials.

We assure you of our full cooperation in the matter and are ready to provide any further details required.
