Subject: Complaint for registration of FIR regarding physical assault, grievous injuries, and life threats against a senior citizen.

Respected Sir/Madam,

I, **Prithees Lahiri**, son of Lt.Kshitish Ch.Lahiri aged 70 years, residing at Dental Heart, Derozio Sarani, Ward No.20, Subhashpally, Siliguri, do hereby lodge this formal complaint against the following persons for a pre-planned and violent physical assault on me and my wife:

Ashish Ch. Lahiri (Brother) and Son of Lt.Kshitish Ch. Lahiri
Chandana Lahiri (Wife of Ashish Ch. Lahiri)
Debojyoti Lahiri (Son of Ashish Ch. Lahiri)
Debopriya Lahiri (Daughter of Ashish Ch. Lahiri)

All the above-named accused persons reside at the same address: **Dental Heart, Derozio Sarani, Subhash Pally, Siliguri, Ward No. 20, District Darjeeling, West Bengal.**

The Incident:

On February 27, 2026, at approximately 11:30 PM, while I was at my residence, the aforementioned accused persons entered into a confrontation with me regarding an ongoing property dispute. With a clear and common intention to cause bodily harm and intimidate me into withdrawing legal claims, the accused began hurling filthy abuses and death threats. Suddenly, Debjyoti Lahiri, at the instigation of Ashis Lahiri, viciously and intentionally struck me on my nose with his fist with extreme force. This was a targeted blow intended to cause permanent disfigurement or fracture. The impact resulted in an immediate nasal hemorrhage (profuse bleeding) and excruciating pain. I suspect a nasal bone fracture (subject to medical confirmation).

When my wife, Smt. Shyamali Lahiri, rushed to save me, she was criminally force-handled, pushed, and outraged by Chandana and Debopriya Lahiri. They used criminal force to prevent her from assisting me, while Ashis Lahiri continued to issue threats of "finishing us off" if we did not vacate the premises.

Background & Criminal Intimidation:

There is a history of continuous harassment and encroachment for the last three years. The accused are systematically using physical violence as a tool to bypass the judicial process regarding our pending property case. We are living in a state of constant terror for our lives.

Prayer:

Given that I am a Senior Citizen, I am highly vulnerable. I request you to:
Immediately register an FIR for Voluntary Causing Grievous Hurt and Criminal Intimidation to a Senior Citizen
Arrest/Interrogate the accused to prevent further life-threatening attacks.
Ensure the safety and protection of myself and my wife.
