**Subject: Complaint regarding rash and negligent driving.**

Respected Sir/Madam,

I, **Piyush Agarwal**, S/o **Sunil Agarwal**, resident of Netaji Subhash Chandra Road, Prakash Nagar, Siliguri (M. Corp.), P.S. Bhaktinagar, District Jalpaiguri, West Bengal - 734001, most respectfully submit this complaint on behalf of my father.

That on the morning of 28/02/2026, at about 11:00 A.M., my father **Sunil Agarwal**, aged about 57 years, was going towards the market on his **Suzuki Access scooty bearing Registration No. WB73M8948**. That at that time, near Air View, a bus bearing Registration No. **WB73 A 6819**, driven by one **Tulsi Mahonta (59 years)**, S/o **Late Nagen Mahonta**, resident of **Kayakanda, P.S. Kharibari, District Darjeeling**, came from behind and hit my father's scooty due to rash and negligent driving. That due to the severe impact of the accident, my father fell down on the road and sustained serious injuries. He was immediately shifted to the hospital where he has been undergoing treatment since yesterday. His right leg is not functioning properly, and the doctors have advised further treatment. The approximate medical expenses have already reached around ₹2,50,000/-. That after causing the accident, the bus driver attempted to flee from the spot, but with the help of local public, he was apprehended. That the accident occurred solely due to the rash and negligent driving of the said bus driver. That my father is the head of the family and the sole earning member. Due to this accident, our family is facing severe financial hardship along with mental trauma.

Therefore, I most humbly request you to kindly register an FIR against the accused driver under appropriate sections of law for rash and negligent driving causing grievous hurt and take necessary legal action.

I further request you to kindly condone the delay in lodging this complaint, as I have been busy attending to my father's medical treatment due to his serious condition.

I shall remain ever grateful for your kind intervention and necessary action.
