In producing herewith 04 (four) arrested accused persons namely (1)Manojit Ghosh (M/24 Years) S/O- Madan Ghosh of Ghorarbari Bholamaore near Gas Godown PS- NJP, Dist.- Jalpaiguri (2) Chhoton Chakraborty (M/41 Years) S/O- Lt. Akhil Mohan Chakrabarty of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri (3) Ashim Das (M/36 Years) S/O- Lt. Amar Das of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri and (4) Chanchal Das @ Asit Das (M/44 Years) S/O- Lt. Amar Das of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri under proper arrest memo and ground of arrest has duly been communicated with them.

In this regard, I ASI Malay Modak presently attached to NJP PS, Siliguri Police Commissionerate under your kind control beg to state that on 02/03/2026 at 21:10 hrs I received one telephonic information from SPC Control Room that one child marriage is going on at Ghorarbari Bholamaore Gas Godown PS- NJP, Dist.- Jalpaiguri. The matter was diarized in General Dairy vide NJP PS GDE No- 98 Dated 02/03/2026. As per the instruction of you myself alongwith SI Binup Mahato, SI - Tanmay Kundu with other police personnel left for Ghorarbari Bholamaore Gas Godown PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 21:20 hrs we reached there and found that one minor girl aged 17 yrs is getting married with Manojit Ghosh (M/24 Years) S/O- Madan Ghosh of Ghorarbari Bholamaore Gas Godown PS- NJP, Dist.- Jalpaiguri where one person namely Chhoton Chakraborty (M/41 Years) is conducting the marriage as purohit (priest), other person namely Ashim Das (M/36 Years) S/O- Lt. Amar Das of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri and Chanchal Das @ Asit Das (M/44 Years) S/O- Lt. Amar Das of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri are present as witness of said marriage. It is clear that the all noted accused persons were consciously involved in an act of child marriage. On interrogation they admitted that a marriage is going on in between Manojit Ghosh as Groom and one minor girl aged 17yrs as bride. Accordingly, I arrested the accused persons namely Manojit Ghosh (M/24 Years) S/O- Madan Ghosh of Ghorarbari Bholamaore Gas Godown PS- NJP, Dist.- Jalpaiguri (2) Chhoton Chakrabarty (M/41 Years) S/O- Lt. Akhil Mohan Chakrabarty of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri (3) Ashim Das (M/36 Years) S/O- Lt. Amar Das of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri and (4) Chanchal Das @ Asit Das (M/44 Years) S/O- Lt. Amar Das of Suryasen Colony, Block- C, PS-NJP, Dist- Jalpaiguri under proper arrest memo and ground of arrest has duly been communicated with them. Whole process were done in between 21:20 hrs to 21:45 hrs on 02/03/2026.

Hence, I pray to you a specific case may kindly be started against the above mentioned 04 (four) arrested accused persons under proper section of law and arrange for its investigation.
