In producing here with the arrested accused person namely Barun Biswas 40 yrs S/O- Late Kestotal Biswas R/O- Sarbahara Colony, Matangini II, ward no- 28 PS- Siliguri, Dist- Darjeeling along with the following seized articles.

Twelve (12) sealed bottle of Himalayan Gold 60 up country Spirit each bottle containing 600ml. total quantity or liquor 600 ml x 12 = 7.2 liters value of seized article Rs /- 170 (One Seventy Sixty) each, total value of Rs 170x12= Rs- 2040/- (Two Thousand Forty Rupee)


With due respect and humble submission I, ASI Rabin Lama of Siliguri PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the accused Barun Biswas 40 yrs S/O- Late Kestotal Biswas R/O- Sarbahara Colony, Matangini II, ward no- 28 PS- Siliguri, Dist- Darjeeling to the effect that on 03.03.26 at about 15.35 hrs received a source information from Sarbahara Colony Bazar, ward no- 28 under Siliguri PS, that one Barun Biswas is busy to selling huge quantity of liquor to his design customer in his shop at Tikiapara, for his wrongful gain without any documents or license. The facts diarized in general diary vide Siliguri PS GDE no - 135 dated 03.03.2026. Accordingly as per your instruction myself along with SI Shib Shankar Das, ASI Minhaz Al Kader, ASI Subir Sen. and Constable- 160 Soumen Sarkar of Siliguri PS left PS to verify and veracity of the information all are posted at Siliguri police station. On reaching I contacted with source and on being identified by the source I along with force held raid in the shop of Barun Biswas at Tikiapara Bazar. On searched I recovered Twelve (12) sealed bottle of "Himalayan Gold" 60 up country spirit each bottle containing 600 ml from the broken meat case on his shop situated at Sarbahara Colony Bazar. On interrogation he disclosed his Identity as Barun Biswas 40 yrs S/O- Late Kestotal Biswas R/O- Sarbahara Colony, Matangini II, ward no- 28 PS- Siliguri, Dist- Darjeeling and he also admitted his guilt and stated that he selling the Id liquor to his design customers from since long without any license or documents. Accordingly I seized the same i.e Twelve (12) sealed bottle of Himalayan Gold 60 up country Spirit each bottle containing 600ml. total value of seized article Rs /- 170 (One Seventy Sixty) total value of Rs 170x12= Rs- 2040/- from the exclusive & conscious possession of accused person duly sign by the accused as well as witnesses and I arrested him as per proper section of law as he violated the rules and norms of Bengal excise act. The whole process of search and seizure was recorded with audio-video graphed. (The seizure was made in between 15.52 hrs to 16.05 hrs)

I therefore request you a specific case may kindly be started against the arrested person namely Barun Biswas 40 yrs S/O- Late Kestotal Biswas R/O- Sarbahara Colony, Matangini II, ward no- 28 PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation.
