Most Humbly, I **Sri Abhoy Das**, Son of Late Dilip Das, Resident of Bholamore, Jamuribita, Near Gas Godown, P.O Sahudangi Hat, P.S-New Jalpaiguri, Dist- Jalpaiguri, do hereby lodge this complaint before you to stating that yesterday on dated-02.03.2026 between 9:30 PM to 10:30 PM my elder sister namely Miss **Ankita Das**, resident of above mention address was returning to her house from her work and at that time when she passed by her two wheeler Scooty bearing No **WB-73-N-5085**. Near Sanai Bhawan, Alu Chowdhury more, Babu Para, Under Siliguri Police Station, A Person who driving a car bearing no **WB-74-AH-3774** who was coming from behind was at a high speed driving in negligence manner and also in intoxicated situation knowing fully well that driving in such negligence manner would kill any traveller or person and despite having such knowledge he was driving the car negligently resulting in hitting my sister scooty very badly due to which she felt down on the Road beside the white line and got senseless and this person who was the driver without stopping his vehicle dragged my elder sister to about near 500 mt. and moreover the driver also passed the car over her body and head causing serious damage and injury from the hip part and making her unable stand, Local people came running out and took her Siliguri District Hospital for treatment and the local persons informed me by my sister's mobile phone and Stated the total incident and giving me the information as well as Number of the vehicle, My sister was admitted whole night but doctor suggest me that she get severe injury to her back and head but due to wearing helmet she saved her life but she get injury in her head and back and The Doctor's also suggest me to take her to another private Hospital and I take her and admitted in Star Hospital Under Neurologist and Orthopadic specialist Doctor. Now Even her situation is very critical and serious.

Now I am requesting before you to kindly registered my complaint as FIR and take necessary step form your ends and punished this person who driving the said car by intoxicated situation and hitted my sister scooty having intention to kill and escape from the incident place I am highly obliged with you.
