Sir,

In producing herewith one accused person named Ashok Kr Yadav (30 yrs) S/O Late Kameswar Yadav of Bhawara Kotwali Chawk, Mishriganj, PS- Madhubani, Dist. Madhubani, Bihar under arrest along with following articles under proper seizure list viz :- one (01) maroon colour trolley bag styled as "fastrack" containing 17 (seventeen) bottles of ROYAL STAG SUPERIOR WHISKY each bottle containing 750 ml. i.e. (750 ml X 17 = 12.750 Litres) marked as "Exhibit-A" out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1".

I, ASI Bikash Roy of Pradhan Nagar P.S, Siliguri Police Commissionerate would like to lodge this written complaint against the above mentioned arrested accused person namely Ashok Kr Yadav (30 yrs) S/O Late Kameswar Yadav of Bhawara Kotwali Chawk, Mishriganj, PS- Madhubani, Dist. Madhubani, Bihar to the effect that today on 02.03.2026 at around 21.25 hrs I received a specific source information that one person is standing at Siliguri Junction near SIDA building under PS- Pradhan Nagar, Dist. Darjeeling with a maroon colour Trolley bag containing illegal liquor inside the trolley bag and waiting there for a Bihar bound bus. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 95 dated 02.03.26 and informed the fact to you. As per your kind order and direction, myself along with C/119 Tannoy Roy and force left for Siliguri Junction by Govt vehicle with investigation kit to verify the veracity of the information. At around 21.35 hrs myself along with force arrived at Siliguri Junction and contact with two independent witnesses namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Rajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at act as witness if any search and seizure would be made upon which they agreed. Then, I contacted with my source and being pointed by the source, I noticed that one person was standing at near SIDA building, Siliguri Junction with a maroon colour trolley bag in his possession. Accordingly, we cordoned the place from every corner with due care and caution and managed to detain him with a maroon colour trolley bag in his possession. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation the detained person disclosed his name and identity as noted above and on further interrogation he disclosed that there are total 17 bottles of Royal Stag Whisky inside the trolley bag in his possession. Further being searched the trolley bag under the possession of said detained person recovered 17 (seventeen) bottles of ROYAL STAG SUPERIOR WHISKY each bottle containing 750 ml. i.e. (750 ml X 17 = 12.750 Litres). On demand he failed to produce any valid license/papers for carrying such articles. On further interrogation he stated that he collected the said quantity of illegal liquor clandestinely from one of his suppliers and waiting there for a Bihar bound bus with a view to sale the same in Bihar in high rates during Holly festival for his wrongful gain. On further grilling, he confessed his guilt and stated that is running such illegal business of illegal liquor since few months for his wrongful gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned detained person namely Ashok Kr Yadav (30 yrs) S/O Late Kameswar Yadav of Bhawara Kotwali Chawk, Mishriganj, PS- Madhubani, Dist. Madhubani, Bihar after observing all formalities of arrest, informing him regarding the ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. The entire process of seizure and label has been made in between 22.15 hrs. to 22.45 hrs on 02.03.2026 at the spot under the coverage of vedigraphy as per norms of BNSS. Further, I informed the wife of the accused namely Secma Kumari over mobile phone having Mobile No 9523304481 regarding arrest of Ashok Kr Yadav and also informed that the said accused will be forwarded before Ld ACJM, Siliguri on 03.03.26 morning.

I, therefore pray before your good self that a specific case may kindly be initiated against accused person namely Ashok Kr Yadav (30 yrs) S/O Late Kameswar Yadav of Bhawara Kotwali Chawk, Mishriganj, PS- Madhubani, Dist. Madhubani, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
