In producing herewith one (01) arrested accused person namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) One (01) white and red colour paper made cartoon styled as "Kalmi DATES" containing 54 (fifty four) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup " CHOCO +" Cough Syrup each bottle containing 100 ml. i.e total (54 X 100 ml= 5400 ml) having batch No POSLG094, Mfg date 10/2025, Exp date 09/2027, MRP Rs 197.00 each - Marked as Exhibit- "A" (ii) one black and purple colour scooty (NTORQ 125) having Registration No WB-74-BK-1694 with it's key- Marked as Exhibit-"B" and (iii) one (01) androied Mobile Phone " VIVO having IMEI No 868526065705514/868526065705506 with SIM having Mobile Phone No 8207228327 Marked as Exhibit "C". I, SI Ribam Lepcha S/O Late Yakub Lepcha of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 02.03.2026 at 19.25 hrs I received a reliable specific secret source input that one pearson would be come to Dagapur in front of Savin Kingdom Gate under PS - Pradhan Nagar, Dist. Darjeeling by a scooty having Registration No WB-74-BK-1694 with huge quantity of illegal Cough Syrup in his possession to delivery the same to his design customer. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 90 dated 02.03.2026 and I informed to you in writing.

Subsequently, being directed by you at about 19.40 hrs myself along with ASI Biplab Kr Das, ASI Prabal Sarkar, ASI Bikash Roy and others force of Pradhan Nagar PS, SPC left for Dagapur near Savin Kingdom under PS Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 91 dated 02.03.2026 and M.C.C. No. 417/26 dated 02.03.2026. I also informed one Videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, Ward No-22, PS- Siliguri, Dist. Darjeeling over telephone and requested him to come to Dagapur near Savin Kingdom under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Sajal Das and share the information with him and directed him to come to Dagapur near Savin Kingdom to accompany as well assist us.

At around 19.55 hrs we arrived at Dagapur near Savin Kingdom under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source while he informed that the person who possessing cough syrup will come to near Savin Kingdom Gate shortly by a scooty having Registration No WB-74-BK-1694 to deliver the same to his customers. Then, I contacted with two available independent persons namely (i) Gaffar Islam (45 yrs) S/O Lt Md Masiruddin of Sukna T.E. PO- Gulma, PS- Pradhan Nagar, Dist. Darjeeling (M. No 8509323915) and (ii) Md Sarifuddin (38 yrs) S/O Md Mofizuddin of Damagram, PO- Gulma T/E, PS- Pradhan Nagar, Dist. Darjeeling (M. No 81455075510) and shared the information with them and requested them to remain present at the spot and act as independent witness if any search and seizure would be made upon which they agreed and expressed their willingness to co operate with me as well as to act witness. I also issued notice in writing upon both the above mentioned two independent witnesses which are acknowledge by them. In the mean time RT mobile officers ASI Sajal Das along with force came to the spot at Dagapur near Savin Kingdom to assist us. There after, I again contacted my source while he stated that the suspect carrying illegal cough syrup will come shortly by a scooty having Registration number WB-74-BK-1694. At around 21.20 hrs I found that one scooty having the same Registration number noted above came from Salbari side and stopped at Dagapur near Savin Kingdom gate. Accordingly, we cordoned the place from every corner with due care and caution and managed to detain the said scooty and the rider of the scooty. On search the scooty, one white and purple colour paper made cartoon was found on the leg passage of the scooty. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling and also disclosed that he is carrying 54 bottles of cough syrup inside the carton in his possession and came there to deliver the same to his designated customer for his wrongful gain. Then, I issued notice in writing to him whether he wanted to search the paper made cartoon in his possession in presence of an Executive Magistrate or any Gazetted Officer as per norms of u/s 50 of NDPS Act, upon which he agreed to be searched in presence of any of the above noted officers.



Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 21.50 hrs the above named videographer arrived at the spot at Dagapur near Savin Kingdom Gate under PS- Pradhan Nagar, Dist. Darjeeling with his camera. Accordingly, I served a notice to him for videography the entire process of search and seizure if required. Further at around 22.10 hrs on 02.03.26 you arrived at the spot at Dagapur near Savin Kingdom Gate under PS- Pradhan Nagar, Dist- Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due to night hours no Executive Magistrate was available and as a gazetted officer you are legally authorised to give order to search the cartoon under the possession of the suspect.

Then, I served a notice to you to supervise the entire process of search and if required of seizure. Thereafter on camera, I offered both the independent witnesses noted above and the detained person to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Then, in presence of you and independent witnesses noted above, on camera, I searched the white and purple colour paper made cartoon under the possession of above mentioned detained person namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling and recovered 54 (fifty four) sealed bottles of bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "CHOCO +" Cough Syrup each bottle containing 100 ml. i.e total (54 X 100 ml= 5400 ml) having batch No POSLG094, Mfg date 10/2025, Exp date 09/2027, MRP Rs 197.00 each. On demand in presence of you and independent witnesses, the above named detained person namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling failed to produce any valid document/papers for possessing or carrying such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers for his wrongful gain. He also stated that he was running such a business illegally for the last few months for his wrongful gain.

Accordingly, I seized the said articles viz :- (i) One (01) white and red colour paper made cartoon styled as "Kalmi DATES" containing 54 (fifty four) sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup "CHOCO +" Cough Syrup each bottle containing 100 ml. i.e total (54 X 100 ml= 5400 ml) having batch No POSLG094, Mfg date 10/2025, Exp date 09/2027, MRP Rs 197.00 each - Marked as Exhibit- "A" (ii) one black and purple colour scooty (NTORQ 125) having Registration No WB-74-BK-1694 with it's key- Marked as Exhibit-"B" and (iii) one (01) android Mobile Phone " VIVO having IMEI No 868526065705514/868526065705506 with SIM having Mobile Phone No 8207228327 Marked as Exhibit "C" from the possession of accused person namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling under proper seizure list in presence of you and above mentioned two independent witnesses and obtained their signatures which is acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused at the spot. The entire process of search, seizure and labelling were made in between 22.20 hrs to 22.45 on 02.03.26 under the coverage of a videography executed by the videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, Ward No-22, PS- Siliguri, Dist. Darjeeling at the spot.

From the above noted facts and seizure of incriminating articles, it is quite evident that the offender namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling is involved in procuring and selling "Codeine Phosphate based Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities of arrest, informing him regarding the ground of his arrest and brought to Pradhan Nagar PS for further investigation. I also informed to the sister of the accused namely Pinki Gupta over Mobile phone having Mobile No 9832584547 duly provided by the accused regarding arrest of accused person namely Sujit Prasad from the spot.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested person namely Sujit Prasad (32 yrs) S/O Late Bharat Prasad of Shiv Nagar, Darjeeling More presently residing at Agam Singh Nagar, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling and arranged its investigation.
