Respected Sir,

With due respect, I, **SRI SUBHAM DAS**, S/o Sri Uttam Das, resident of Ashik Ghat Road, Janata Nagar, Ward No. 44 S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri in the State of West Bengal would like to lodge this Written Complaint before your good Office to the effect that on today i.e. 03.03.2026 at about 06:30 PM, along with my friend namely Sri Dhiman Sharma were returning to our house via Payel Cinema Hall Road and when we reached near Kali Temple at Dashrath Pally at that point of time some boys who were standing on the road near Dashrath Pally Sporting Club namely 1) Sri Rintu Sarkar, Son of Pintu Sarkar, 2) Ananda Saha, Son of unknown, 3) Amit Roy, Son of unknown stopped our way by showing knives on their hands and demanded money and they threatened that if we do not pay them money they will not hesitate to kill us and the above named persons pulled my friend inside the club and the above named persons in connivance with other 10-15 other persons who were already present in the club room and having liquor inside the club started to assault my friend with fists, blows, kicks and iron punch and when I entered into the club for rescuing my friend, the above mentioned persons also assaulted me mercilessly and they snatched the purse of my friend containing cash amounting Rs. 2290/- and they have torn our wearing apparels.

Sir, it is to be mentioned here that the above mentioned persons assaulted both of us mercilessly and as such we sustained severe and grievous injuries on our body and we rushed to the Siliguri District Hospital and visited the Emergency O.P.D. and we advised for X-ray, presently our condition is very pathetic and the above mentioned persons are threatening us to not to go to the Police otherwise they will again assault us and ruin our life as they are having previous criminal antecedents.

I, therefore, request you to kindly investigate the matter properly and treat this complaint as FIR and please take necessary legal action against the aforesaid culprits/miscreants as per the provision of law and oblige thereby.
