In producing herewith 01 (one) accused person namely Mukesh Biswakarma @ Anish (M/28 yrs) S/O Rajen Biswakarma of Ranipool, Nandok, P.O.+ P.S Ranipool, Dist. East Sikkim under arrest and the following articles under seizure viz :- (i) One (01) iron made improvised small fire arm measuring approx 22 cm in length including its 08 cm iron made pistol grip, having approx 12 cm barrel, trigger, firing pin and firing hammer in proper working condition - Marked as Exhibit "A" and (ii) 01 (one) live ammunition- Marked as Exhibit - "B". I, ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Mukesh Biswakarma @ Anish (M/28 yrs) S/O Rajen Biswakarma of Ranipool, Nandok, P.O.+ P.S Ranipool, Dist. East Sikkim to the effect that tonight i.e. on 04.03.26 at 21.05 hrs, I received a specific secret source information that one person is moving to near SNT, Siliguri Junction with illegal fire arm with a view to sell the same to his designed customer or to commit any heinous crime at Siliguri Junction area. Accordingly, I diarized the information in PS General diary vide Pradhan Nagar PS GDE No. 213 dated 04.03.26 and informed the fact to you. As per your kind order and direction myself along with ASI Prabal Sarkar and force left for Siliguri Junction near SNT with investigation kit to work out the information in hand by Govt. vehicle, This refers to Pradhan Nagar PS MCC No 432/26 dated 04.03.26. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. On the way to Siliguri Junction I requested night RT Van Officer SI Abir Dhar to come to near SNT, Siliguri Junction to accompany with us and also inform one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling and requested him to come to near SNT, Siliguri Junction with his camera for the purpose of videography if required. After arrival at near SNT, Siliguri Junction I contacted with two independent person namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Rajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and requested them to remain present and act as witness during search and seizure if required upon which they agreed. At 21.55 hrs being pointed by the source, I noticed one person was standing beside boundary wall of SNT, Siliguri Junction. Accordingly, we cordoned the place from both the side with due care and caution and managed to detain him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information that the suspect possessed fire arm and ammunition, hence, immediately, I searched him and recovered the following articles viz -(i) One (01) iron made improvised small fire arm measuring approx 22 cm in length including its 08 cm iron made pistol grip, having approx 12 cm barrel, trigger, firing pin and firing hammer in proper working condition and (ii) 01 (one) live ammunition from his exclusive and conscious possession. On demand he failed to produce any document in respect of the fire Arm and ammunition which was found in his exclusive and conscious possession. Accordingly, I seized the above mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledge by the accused person. The search seizure and label were made in between 22.15 hrs to 23.05 hrs on 04.03.26 at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS. On further interrogation he admitted his guilt and disclosed that he collected the said fire arm and ammunition from Jharkhand and came to Siliguri to hand over the same to his designed customer for his wrongful gain. Further I informed the guardian of the accused regarding arrest of Mukesh Biswakarma and also informed that the said accused will be forwarded before Ld ACJM, Siliguri on 05.03.26 morning.

Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, I then arrested him under proper memo of arrest and observing all the formalities for violating the norms of Arms Act. I informed him regarding grounds of his arrest and also issued copy of memo of arrest and ground of arrest to him.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Mukesh Biswakarma @ Anish (M/28 yrs) S/O Rajen Biswakarma of Ranipool, Nandok, P.O.+ P.S Ranipool, Dist. East Sikkim is desperate and dangerous in nature and he was carrying the said Fire arm and live ammution with an objective to sell the same or to commit any heinous crime in the locality.

As he willfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Mukesh Biswakarma @ Anish (M/28 yrs) S/O Rajen Biswakarma of Ranipool, Nandok, P.O.+ P.S Ranipool, Dist. East Sikkim under proper section of law and its investigation may kindly be arranged.
