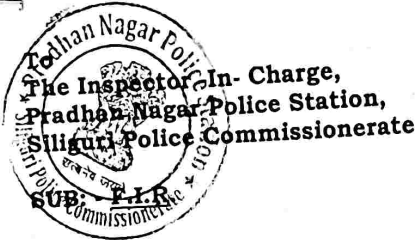

Sir,

In producing herewith one accused person namely Anurag Rai (25 yrs) S/O Ratna Bahadur Rai of Ranka Sangthung, PS- Sadar, Gangtok, Dist. - East Sikkim under arrest along with following articles under proper seizure viz :- one blue colour bag styled as "adidas" containing 02 (two) paper made cartoons each cartoon containing 20 (twenty) bottles i.e. (20 x 02=40 bottles) of "HIMALAYAN GOLD" 60 UP India made liquor each bottle containing 600 ml. i.e. (40 bottle x 600 ml = 24 Liters) marked as "Exhibit-A" out of which 01 bottle of the same taken from each cartoon as sample for examination and marked as "Exhibit-A1" and "Exhibit-A2".

I, ASI Bikash Roy of Pradhan Nagar P.S, Siliguri Police Commissionerate would like to lodge this written complaint against the above mentioned arrested accused person namely Anurag Rai (25 yrs) S/O Ratna Bahadur Rai of Ranka Sangthung, PS- Sadar, Gangtok, Dist. - East Sikkim to the effect that today on 04.03.2026 at around 21.45 hrs I received a specific source information that one person is standing at Namchi Taxi Stand, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling with a blue colour bag containing illegal liquor inside the bag with a view to sale the illegally to his design customer for his wrongful gain. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 216 dated 04.03.26 and informed the fact to you. As per your kind order and direction, myself along with ASI Prabal Sarkar, C/119 Tanmoy Roy and force left for Siliguri Junction by Govt vehicle with investigation kit to verify the veracity of the information. At around 21.55 hrs myself along with above mentioned officer and force arrived at Siliguri Junction and contacted with two independent witnesses namely (i) Sujit Mahato (38 yrs) S/O Ramananda Mahato of Lalpool, Nemai, PS- Matigara, Dist. Darjeeling and (ii) Suraj Routh (28 yrs) S/O Ram Avthar Routh of Mahananda Colony, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at act as witness if any search and seizure would be made upon which they agreed. Then, I contacted with my source and being pointed by the source, I noticed that one person was standing at Namchi Taxi Stand, Siliguri Junction with a blue colour bag in his possession. Accordingly, we cordoned the place from every corner with due care and caution and managed to detain him with a blue colour bag in his possession. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation the detained person disclosed his name and identity as noted above and on further interrogation he disclosed that there are total 40 bottles of 60 up Himalayan Gold India made liquor inside the bag in his possession. Further being searched the bag under the possession of said detained person recovered 02 (two) separate paper made cartoons each cartoon containing 20 (twenty) bottles i.e. (20 x 02=40 bottles) of "HIMALAYAN GOLD" 60 UP India made liquor each bottle containing 600 ml. i.e. (40 bottle x 600 ml = 24 Liters) which were kept hidden inside the bag. On demand he failed to produce any valid license/papers for carrying such articles. On further interrogation he stated that he collected the said quantity of illegal liquor clandestinely from one of his suppliers and waiting there to deliver the same to his design customers for his wrongful gain. On further grilling, he confessed his guilt and stated that is running such illegal business of illegal liquor since few months for his wrongfull gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned detained person namely Anurag Rai (25 yrs) S/O Ratna Bahadur Rai of Ranka Sangthung, PS- Sadar, Gangtok, Dist. - East Sikkim after observing all formalities of arrest, informing him regarding the ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. The entire process of seizure and label has been made in between 22.25 hrs to 23.15 hrs on 04.03.2026 at the spot under the coverage of vediography as per norms of BNSS. Further, I informed the guardian of accused regarding arrest of Anurag Rai and also informed that the said accused will be forwarded before Ld ACJM, Siliguri on 05.03.26 morning.

I, therefore pray before your good self that a specific case may kindly be initiated against accused person namely Anurag Rai (25 yrs) S/O Ratna Bahadur Rai of Ranka Sangthung, PS- Sadar, Gangtok, Dist. - East Sikkim under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


