Sir,

In producing herewith the accused person named Rabin Saibo, aged 33 years, s/o- Kantalal Saibo, resident of Dhimal Jote, Tarabari, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. One (01) red colour plastic jar containing five (05) ltrs 'Chullu', out of which 01 bottle is taken out as sample and marked as Exhibit-A.
 2. One (01) green colour plastic jar containing five (05) ltrs 'Chullu', out of which 01 bottle is taken out as sample and marked as Exhibit-B.
 3. One (01) yellow colour plastic jar containing five (05) ltrs 'Chullu', out of which 01 bottle is taken out as sample and marked as Exhibit-C.
 4. One (01) yellow colour plastic jar containing five (05) ltrs 'Chullu', out of which 01 bottle is taken out as sample and marked as Exhibit-D.
 5. One Atlas jents bicycle.

I, ASI Amit Lama of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person named Rabin Saibo, aged 33 years, s/o- Kantalal Saibo, resident of Dhimal Jote, Tarabari, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on 28.02.2026 at around 20:15 hrs in course of performing scheduled PC mobile van duty vide Bagdogra PS GDE No. 1428 dated 28.02.2026, I received reliable source information that one suspect has come at Bagdogra hatkhola bazar with huge quantity of liquor (chullu) in his possession with a view to sell the same illegally to his designed customer for his wrongful gain. Accordingly, I along with ASI Munna Ahmed, VP/01 Anselam Kujur, CV/386, Kishor Ranjan Howladar & CV/375 Jogesh Barman left for Bagdogra hatkhola bazar under Bagdogra PS, SPC by Govt. vehicle No. WB61A/0137 to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as of the escape of the offender. At around 20:30 hrs we reached at Bagdogra hatkhola bazar and being indication & identification by source at around 20:32 hrs I managed to apprehend one suspect with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Rabin Saibo, aged 33 years, s/o- Kantalal Saibo, resident of Dhimal Jote, Tarabari, PS- Bagdogra, Dist- Darjeeling (not verified). We disclosed our identity to him and the input we had. We searched for the independent witnesses to be present there as witness during the process of search, seizure, if any. Two independent witnesses named Dhupnath Bhagat, aged 56 years, s/o- Late Ram Ayodha Bhagat, resident of Bagdogra hatkhola bazar, PS- Bagdogra, Dist- Darjeeling and Rahul Gupta, aged 21 years, s/o- Subh Nayak Gupta, resident of Hare Krishna Pally, PS- Bagdogra, Dist- Darjeeling (Ph. No. 9932248280) was there to witness the process of search and seizure, if any. Then, we searched the suspect who had carried a loaded bag on his bicycle. On searching the bag, four (04) plastic jars of different colour containing five (05) ltrs 'Chullu' in each jar (total 20 ltrs chullu) was recovered from his possession. On demand, the detainee failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he has been stocking, possessing & selling liquor illegally since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) including one bicycle from his possession under proper seizure list in presence of independent witnesses and at last, I arrested the involved accused Rabin Saibo (as noted above)

Therefore, I request that a specific case under proper section of law may kindly be started against the involved arrested accused person named Rabin Saibo, aged 33 years, s/o- Kantlal Saibo, resident of Dhimal Jote, Tarabari, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation,
