Sir,  
In producing herewith seized articles viz. twenty (20) ltrs Chullu in two yellow colour plastic jars (each of 5 ltrs) under proper seizure list, I, ASI Munna Ahmed of Bagdogra PS, SPC, do hereby lodge this written complaint against the absconding female accused person named Samjana Thapa, aged around 36 yrs, w/o- Bhupen Thapa, resident of Airport more, Gowala Busty, PS- Bagdogra, Dist- Darjeeling to the effect that on 01.03.2026 at 21:05 hrs in course of performing preventive raid duty (pre holi drive) vide Bagdogra PS GDE No. 47 dated 01.03.2026, I received secret source information that a huge quantity of liquor is stored at the shop cum house of one suspect named Samjana Thapa at Airport more, Gowala Busty under Bagdogra PS and the same has been selling illegally. Accordingly, I along with ASI Amit Lama, VP/02 Pradip Roy, CV/386 Kishor Ranjan Hawladar & CV/389 Janak Singh left for Airport more, Gowala Busty to work out the secret source information. At around 21:15 hrs we reached at Airport more, Gowala Busty and being indicated by source we held raid at the shop cum house of the suspect Samjana Thapa to verify the veracity of information. Seeing the police personnel the owner somehow managed to flee away from the spot. On enquiry, it could be learnt that one Samjana Thapa, w/o- Bhupen Thapa, resident of Airport more, Gowala Busty, PS- Bagdogra, Dist- Darjeeling is the owner of said shop cum house and she has been selling liquor to customers illegally. Then we contacted with two local independent witnesses named Sanjana Thapa (46 yrs), w/o- Rajen Thapa and Sabina Thapa (33 yrs), w/o- Bhota Thapa, both are resident of Airport more, Gowala Busty, PS- Bagdogra, Dist- Darjeeling who accompanied us for the purpose of search, seizure. Then we searched the shop cum house in presence of the above mentioned independent witnesses and on search, we managed to recover the above noted liquor from the shop cum house of said Samjana Thapa. On demand, none came forward to produce any valid document/license for stocking and selling that liquor. It could also be learnt that she has been stocking and selling liquor from said shop cum house for a long time for her wrongful gain. Accordingly, I seized that liquor under proper seizure list. The process of search & seizure is made in between 21:20 hrs and 21:36 hrs on 01.03.2026 through audio-video electronic means using Govt. mobile App 'WB E-Shakshya' vides Evidence Certificate No. C-47-56678-20260301215125.

Therefore, I request that a specific case under proper section of law may kindly be started against the involved absconding accused persons named Samjana Thapa, aged around 36 yrs, w/o- Bhupen Thapa, resident of Airport more, Gowala Busty, PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
