
In producing herewith one arrested accused person, namely Bappa Das @ Pucka (22 yrs.) s/o- Lt. Anil Das of Niranjannagar, Bidhyasagar Sarani, ward no.-36, PO- Ghogomali , PS- Bhaktinagar, Dist- Jalpaiguri, along with the following articles under proper seizure list: -  
[1] 22 (Twenty two) sealed bottles of "OYE OYE 70 UP PET India Made Liquor each bottle containing 300 ml, i.e. 300\*22= 6600 ml, having M.R.P. of Rs. 50/-, i.e. 50\*22= Rs.1100/-, blended and bottled by Galaxy C.S. Bottling Plant Nagarkata, dist- Jalpaiguri, West Bengal and is marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample for examination and marked as "Exhibit-A-1".

I, ASI Dinesh Chandra Roy, s/o Lt. Madhu Roy of Ashighar OP, under Bhaktinagar Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted arrested accused person, Bappa Das @ Pucka, to the effect that today, 04/03/2026, at 18:45 hrs, I received a reliable source information regarding the unauthorized storage and sale of illicit liquor at a house in Jaleshwari Bazaar, under Bhaktinagar PS, Dist. Jalpaiguri. This information was duly recorded in the General Diary of Ashighar OP GDE No. 104, dated 04/03/2026 and shared with the Officer-in-Charge. Following his instructions, I led a team to Jaleshwari to verify the veracity of source information, arriving at approximately 19:20 hrs. After a brief period of surveillance awaiting the suspect's arrival, my source identified the accused person and accordingly we detained accused, Bappa Das @ Pucka. During interrogation, he disclosed his identity and admitted to storing and selling illicit liquor without a valid license for personal gain over the past few months. A search of the premises led to the recovery of the seized articles, for which he failed to produce any legal documentation or permits. Consequently, I seized and labeled the liquor under a proper seizure list between 21:16 hrs and 21:24 hrs, documented the process via videography, and arrested the accused after completing all necessary legal formalities on-site and informed him of his ground of arrest.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person Bappa Das @ Pucka (22 yrs.) s/o- Lt. Anil Das of Niranjannagar, Bidhyasagar Sarani, ward no.-36, PO- Ghogomali , PS- Bhaktinagar, Dist- Jalpaiguri, under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.

Received on 04-03-2026 at 22:55 hrs vide Bhaktinagar PS GDE No. 210, & started BKN PS case No- 192/26, dt. 04-03-2026, u/s 46 A (i) of Bengal Excise Act 1903 and ordered to ASI Madhu Sudan Barman for its investigation.
