Sir,

With due respect, I am producing herewith 01 (One) arrested accused person namely Kendhelu Barman (48 Years Approx), S/o- Mota Barman of Palashguri Jote, PO-New Chumta, PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. One TATA Dumper having displayed No- WB 73 D 0246 loaded with river bed materials (Sand).

I, Dipak Kr. Chhetri, presently attached with Matigara PS under your kind control, beg to state that on 28.02.2026, during my night mobile van duty, vide Matigara PS GDE No. 1684, Dated- 28.02.2026, when myself along with force namely C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all are of Matigara PS, SPC were at Tut Bagan, PO+PS- Matigara, Dist- Darjeeling, at about 00.45 hrs on 28.02.2026, found that one TATA Dumper having displayed No- WB 73 D 0246 was coming from Bashbari Ghat towards Khaprail more. Accordingly, I stopped the vehicle and found the vehicle was loaded with river bed materials (Sand). On demand the driver could not produce any valid or relevant documents in support of said vehicles and he also failed to produce the valid documents relating to the loaded sands. On further grilling he also stated that he procured the sand fraudulently somewhere from Bashbari Ghat and taking the same for disposal somewhere for his wrongful gain. Accordingly, I informed to the matter I/C, Matigara PS over telephone and as per his direction, I seized the above noted loaded vehicle by preparing proper seizure list in presence of independent witnesses, the whole process of search and seizure was made in between 00:55 hrs to 01:05 hrs by WB E- Sakshya application as per law, after that I arrested the accused driver namely Kendhelu Barman (48 Years Approx), S/o- Mota Barman of Palashguri Jote, PO-New Chumta, PS- Matigara, Dist- Darjeeling by preparing proper memo of arrest and informed him ground of his arrest.

Therefore I pray before you a specific case may kindly be started against the driver/ owner of the vehicle namely Kendhelu Barman (48 Years Approx), S/o- Mota Barman of Palashguri Jote, PO-New Chumta, PS- Matigara, Dist- Darjeeling, and the seized vehicle bearing Reg. No. WB 73 D 0246 under proper section of law and arrange for its investigation.
