That I along with Mink Gzmer,

Shash Baha Bisyat khalka and Riyon Lama

and Praamesh Chettri were having dinner and drinks

at Hi-Spirits city center. On the date I had

commenting on how the car is parked and then started using abusive languages very filthy language and slangs against us. I came out and I myself I saw them coming towards us. When we objected towards their behaviour, they became aggressive and the fight was initiated. During the altercation one of them attacked Praamesh Shetti and Riyan Lama with sharp weapons. Both of them were stabbed and are now injured critically. They both were bleeding. The accused person fled the spot after the attack in Maruti Suzuki FRONX with registration No: WB 74 BR 9198 (Blue colour). Praamesh Shetti and Riyan Lama were immediately rushed to the hospital.

Therefore I humbly request that the culprits be arrested and taken into custody.

gore for dinner at Hi - Spills at around  
12:30 A.M. along with Praamish Chetri, Akash Shah  
and Nivesh Gazmer. We had two cars, one was  
a black colour Merna having registration no :

SK01PB6391 and Suzuki Diaz having registration no :

WB24BA1300. Later in Hi - Spills, we met two of  
his friends (Praamish's friends) Riyan Lama and Bigyal  
Thadka and were spending time together peacefully.

While we were returning at around 2:15 AM and  
reached the parking lot all of us were together  
as we were going to our separate houses. I  
then went and sat at the car (Merna) then I  
noticed a group of unknown random men came in  
Riyan was inside the car and he was trying  
to take the car out from the parking, without  
any provocation from our side they started

as both Riya and Praveesh has been grievously  
injured and has been admitted at the hospital.  
Under such circumstance I would be highly obliged  
if you would take this matter into your  
consideration. Later we came to know that the name of the  
men were Satish and Bijay from Devidarga Siliguri.
