Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Sarwan Thakur (44 yrs approx), S/O-Lt. Ram Agya Thakur, of Thakur Tola, Jungle Line, Po- New Chumta, PS- Matigara, Dist- Darjeeling and 09 (Nine) bottles of Himalayan Gold 60 up country sprit each bottle containing 600 ml in total 5.400 Liters amounting Rs:160*9=1440/- and 16 (Sixteen) bottles of Haywards Bold strong beer each bottle containing 650 ml in total 10.400 Liters amounting Rs:1500*16=2400/- seized articles. The ground of arrest duly been communicated with him.

I, ASI Bikash Roy, of Matigara PS, SPC under your kind control beg to state that on 02.03.2026 during special evening patrolling van duty, I received a secret source information that one person as noted above is selling liquor illegally from his grocery shop located at Thakur tola, Jungle line, PO- New Chumta, PS- Matigara, Dist- Darjeeling. Accordingly, myself along with C/523 Sanjit Kundu, and C/219 Sanatan Chitrakar all are of Matigara PS, SPC left for Thakur tola, Jungle line, under Matigara PS to work out the information in hand. At 15:20 hrs we arrived at Thakur tola in the grocery shop of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his shop. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his shop located at Thakur tola, Jungle line, PS- Matigara, Dist- Darjeeling for his wrongful gain. On being search his shop, the above noted liquor were recovered. On demand he failed to produce any valid documents/license in respect of store/sale of the liquor which were recovered from his house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and informed him ground of his arrest and observing all the formalities of search, seizure and arrest. The whole process of search, seizure, label & arrest was made in between 15:30 hrs to 15:55 hrs on 02.03.2026 by WB E- Sakshya application as per law.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sarwan Thakur (44 yrs approx), S/O-Lt. Ram Agya Thakur, of Thakur Tola, Jungle Line, Po- New Chumta, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
