I, **Smt. Renu Bala Barman Roy**, W/O- Chittaranjan Barman of Promod Nagar, New Rangia, P.S. Matigara, Dist. Darjeeling, Pin- 734013, would like to draw your attention on the following effect that my daughter namely **Doli Barman (D.O.B. 05.04.2009)**, who reads in class 11, today at around 10:15 A.M my aforesaid daughter went nearby shop, but after 20 to 25 minutes my daughter not return, for which asked my younger daughter to look after the matter but my minor daughter not traceable, then I informed the matter to my husband, who also searched my said daughter here and there but not found and one feature phone (Keypad) without SIM Card was found in our home, but two phone numbers were saved there, for which we several times tried to call those numbers but the numbers were switch off. It is to be noted that in the year of 2023 the aforesaid Nikhil Roy with the help of other persons abovenamed abducted / kidnapped my aforesaid minor daughter for their ill motive but at that time with the help of local peoples my daughter was recovered, at that time aforesaid Nikhil Roy apologized to us that he will never committed such type of offence and aforesaid Mukul Roy and Bokul Roy jointly undertook that his brother will never commit such type of offence and they will take responsibility of their brother for which we did not report matter before the police station.

That after missing my daughter said Nikhil Roy was also missing from his house, so my strong presumption is that the aforesaid Nikhil Roy alongwith his two brothers conjointly hatched up a deep rooted conspiracy to trap my minor daughter from my house.

So, in view of above, you are requested to take proper legal measure against above named persons as per law and also recover my minor daughter as save her life.
