Sir,

With due respect, in producing herewith 01 (one) arrested accused person namely Raja Shaw (37 yrs approx), S/O-Lt. Jogindar Shaw, of Mahamaya colony, Road no. 9, PO-Pradhannagar, PS- Matigara, Dist- Darjeeling and 18 (Eighteen) sealed bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml in total 10.800 Liters amounting Rs:170X18=3060/- seized articles. The ground of arrest duly been communicated with him.

I, ASI Chandra Prakash Adhikari, of Matigara PS, SPC under your kind control beg to state that on 04.03.2026 during special evening patrolling van duty, I received a secret source information that one person as noted above is selling liquor illegally from his house located at Mahamaya colony, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling. Accordingly, myself along with C/523 Sanjit Kundu, and C/219 Sanatan Chitrakar all are of Matigara PS, SPC left for Mahamaya colony, under Matigara PS to work out the information in hand. At 21.00 hrs we arrived at Mahamaya colony in the house of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his house. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his house located at Mahamaya colony, PS- Matigara, Dist- Darjeeling for his wrongful gain. On being search his house, the above noted liquor were recovered. On demand he failed to produce any valid documents/license in respect of sale of the liquor which were recovered from his house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and duly labeled and arrested him under proper memo of arrest and informed him ground of his arrest and observing all the formalities of search, seizure and arrest. The whole process of search, seizure, label & arrest was made in between 21.06 hrs to 21.20 hrs on 04.03.2026.

I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused person namely Raja Shaw (27 yrs approx), S/O-Lt. Jogindar Shaw, of Mahamaya colony, Road no. 9, PO-Pradhannagar, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
