With kind request, I, Sri Gopal Das, Son of Late Paresh Chandra Das of Shantinagar Bow Bazar, P.O. Shantinagar, P.S. Bhaktinagar, Dist: Jalpaiguri, would like to state you as follows :-

1. That yesterday, i.e; on 03.03.2026 at about 11.00 P.M. when was returning home from invitation one Bibek @ Prem Mondal, Bablu Mondal, Shanu Mondal, Gullu Mondal, Abhishek Mondal, Indu Mondal alongwith 9 to 10 antisocial criminals stopped me near Pipeline (Shantinagar Bow Bazar) and started beating me with fist and blows. Some of them carried rod and sharp weapons and hit me with the weapons.
2. That the said Bibek @ Prem Mondal, Bablu Mondal, Shanu Mondal, Gullu Mondal, Abhishek Mondal, Indu Mondal and

their criminal associates snatched my gold ring weighing 5 grams and one gold chain weighing 14 grams.

3. That the said Bibek @ Prem Mondal, Bablu Mondal, Shanu Mondal, Gullu Mondal, Abhishek Mondal, Indu Mondal and their criminal associates continued beating me for a long time causing several injuries on my head, face and several parts of my body.
4. That the said Bibek @ Prem Mondal, Bablu Mondal, Shanu Mondal, Gullu Mondal, Abhishek Mondal, Indu Mondal and their criminal associates were trying to kill me by beating me with sharp weapons and would have killed me unless some of my family members rescued me from the place of occurrence.
5. That I was beaten so badly, I hardly could move and with the help of my family members I somehow went to Siliguri District Hospital at about 01.00 A.M. and the doctors treated me there.
6. That I sustained injuries on several parts of my body and many stitches were required to stop the bleeding and healing

the injuries. The doctors advised me to undergo several tests and stay under medical supervision.

7. That the said Bibek @ Prem Mondal, Bablu Mondal, Shanu Mondal, Gullu Mondal, Abhishek Mondal, Indu Mondal and their associates are the renowned antisocial criminals of this locality and have many criminal incidents in the past.

Under the circumstances, I, therefore request you to kindly investigate the case and punish the offenders according to law.
