I, Sri Tapas Bishui, Divisional Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against **Jaya Das Majumdar, (Ph No.-9064963159), S/o- Sambhu Majumdar, Anandamayee Kali bari road, near market complex, ward no.40, Haidarpara, Siliguri, Dist- Jalpaiguri** for having committed offence as stated here under.

On 05.03.2026 at about 12:40 p.m. acting on a source information I, along with 1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the Domestic premises of Smt. Jaya Das Majumdar and inspected service installation, metering installation of Consumer ID **412060362** in the name of Jaya Das Majumdar. During inspection it was found that electricity was being used unauthorisedly & illegally by Jaya Das Majumdar by reconnecting the deemed disconnected service line of the metering installation that was disconnected previously on 02.08.2024 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Landies & Gyer Ltd, serial no.- **L1011532** installed against Con Id. **412060362** seized by preparing a formal seizure list duly signed by Jaya Das Majumdar and witnesses. The copy of the seizure list handed over to Jaya Das Majumdar and his signature obtained as token of receipt.

As Jaya Das Majumdar have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the deemed disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR.
