I Itcha Shanner, wife of Samuel Khali, aged about 19 years, resident of Rangpo, SIKKIM (permanent), presently staying at Bhaktinagar Siliguri, West Bengal - I, respectfully submit this complaint for your kind consideration.

On 05/08/2026, at about 7:18 PM, when I was present at Limbu Busty, Avinash Pathak, Son of Dewendra Pathak, approached me and wrongfully touched me with the intention to outrage my modesty. The accused used criminal force and behaved in an obscene and indecent manner towards me. He also helded my hands and touched my breast.

Due to his actions, I felt deeply humiliated, frightened and insulted. The incident occurred in the presence of two young children, who can testify to the same.

Such conduct of the accused amounts to a serious offence punishable
