Subject: Complaint regarding physical assault, criminal intimidation, attempt to outrage modesty and attempt to burn alive.

Respected Sir,

I, Ruksana Khatun, daughter of Md. Sukru and wife of Karim, respectfully submit this complaint for your kind consideration and necessary legal action. That yesterday, at my matrimonial home, my mother-in-law, Anjuma Khatun, started quarrelling with me over kitchenware and the space used in the kitchen. Without any valid reason, she suddenly became aggressive and began assaulting me physically. Shortly thereafter, Rubeda Khatun joined her, and both of them beat me mercilessly and scratched my face and neck, causing visible injuries and severe pain. That within moments, Jakir Hussain, in a completely intoxicated condition and wearing only his undergarments, forcibly entered my room. In that state, he grabbed my nightdress (nighty) and attempted to tear it off with the apparent intention of outraging my modesty. Due to my resistance and cries for help, he was unable to carry out his wrongful act. He then threatened me saying, he will rape me "turn my face dark so that I lose my dignity and no one in the village would respect me." This is not the first time such threats and misconduct have occurred. That during the same incident, Sobeda Khatun came with a burning fire stick and shouted, "I will burn you and your kitchen so that this matter never arises again." She tried to set me on fire, but before she could succeed, as I wear off my half-burned sweater just to save myself then a known neighbour intervened and rescued me from the spot. I was immediately taken to the hospital for medical treatment, and the medical prescription is annexed herewith for your reference. That the above acts constitute serious offences including physical assault, criminal intimidation, attempt to outrage my modesty, attempt to commit rape, and attempt to burn me alive. The incident has caused me grave physical injuries, extreme mental trauma, and fear for my life and safety. I therefore humbly request you to kindly register my complaint as an FIR and take strict legal action against all the accused persons in accordance with law. I also request that necessary protection be provided to ensure my safety, as I apprehend further harm from them. I shall remain ever grateful for your prompt and immediate action in this matter.
