Subject: Complaint regarding physical and mental torture, demand for dowry and extra- marital affairs.

Sir,

With due respect, I, Smt. Gita Roy, W/O. Pratap Roy, (D/O. Sri. Tapan Das), resident of Chhoto Siyavita- Ranidanga, P.O- Ranidanga, P.S- Bagdogra, Dist.- Darjeeling, beg to report that I was married to Sri. Pratap Roy of Village- Das Para- Phansidewa, P.O. & P.S- Phansidewa, Dist.- Darjeeling on 26-01-2023. At the time of marriage, my father gave Rs. 10,000=00 only in cash, 25 grams of gold, utensils, lep, toshok, television, byke, fridge, bed and alna to my husband's family as dowry.

After 2/3 months my husband always pressurized me to bring more and more dowry either in cash or gold from my father's house and if I denied, he assaulted me with kicks and fists.

After marriage, I gave given birth to a child namely, Master Rudraditya Roy (14 months) but the attitude of my husband never changed towards me and he never loved my child till date.

That since the last 7/8 months, I discovered that my husband is having an extra- marital affairs with a woman namely, Smt. Priyanka Chakroborty (Dutta), W/O. Sri. Bikash Chakroborty, C/O. Shubasish Chandra Saha, resident of Bharat Singh Jote- Ranidanga, P.O- Ranidanga, P.S- Bagdogra, Dist.- Darjeeling. As I along with my mother caught both of them together yesterday, i.e., 01-03-2026 at Bazar Kolkata, Shivmandir, P.S- Matigara at about 9 p.m., both of them assaulted me and my mother with kicks, fists and byke helmet and injured us brutally. Local people came and rescued both of us and got us admitted in NBMC.

My husband has stopped providing maintenance to me and my child and is wasting family assets on Smt. Priyanka Chakroborty.

I, therefore, pray that necessary step/ steps may kindly be taken about this complaint against the 02 (two) persons named above and oblige.
