Most Humbly, I Sri Birju Prasad Gupta, Son of Sri Mahesh Prasad Gupta, Resident of Santoshi Nagar, Near Prince collection cloth shop, Ward No-5 of SMC, P.O & P.S- Yesterday on dated-04/03/2026 Around 4:40 PM at evening when I younger brother namely who passed near ganga nagar Road No-2 then suddenly some persons namely **Raj Yadav and Gobinda Sahani Sunil Bhagat** stopped my brother in intoxicated situation and started tort his shirt forcefully when my brother try to stop them they suddenly started assaulting my brother physically and snatched his money which was kept in his pocket around Rs.1200/- and my brother run away and reached home and after say all the incident to my mother when my mother Smt Gita Devi Gupta, Wife of Sri Mahesh Prasad Gupta came out from the house then suddenly all of them along with other persons namely **Sumit Sahani, Vikram Sahani** started abusing filthy language to my mother when my mother said them that why they are abusing her and why they assaulting my son then they all persons started pushed my mother and started assaulting physically my mother as well as they try tort my mother saree also, they started planting stone upon my house also but the local people run and save my mother but due to hit on my mother's chest she got grievous injury in her chest and getting heavy pain in her chest and we take her to siliguri district hospital where doctor admitted her and take her to observation. Now they all of us came again and again and threatened us that if we lodged any police complaint then they all kill us.

Now I am came before you to kindly take strict action against all the accused persons namely 1. **Raj Yadav** 2. **Gobinda Sahani** 3. **Sunil Bhagat** 4. **Sumit Sahani** 5. **Vikram Sahani** and others who assaulting my brother and mother physically and tort cloth of them as well as planting stone upon my house from your ends.
