Most Humbly , I **Sri Kamal Agarwal**, Son Of Late Amrit Agarwal, R/O MilanPally, Ward No-25 Of SMC, P.O & P.S-Siliguri, Dist Darjeeling, do here by stating that I am the Partner of **RLB INFRA PROJECT LLP**, having office at Milan pally, ward no-25, under Siliguri Police Station further I state that a vacate land which is registered in the name of my company situated at khalpara, vivekananda road, near kela patty, ward no-8 of SMC , under Siliguri Police Station, yesterday on dated-04/03/2026 around 2:pm two persons namely **Sonu Bari**, son of Late Manoj bari, resident of lower bhanu nagar, ward no-43 of SMC, under Bhaktinagar Police Station and another is **Suresh Paswan**, son of Sri Nathu Paswan, resident of tumbajote, under Matigara Police Station, the both person are illegally jump the boundary and enter in the said land and started Consuming alcohol when the local people started protest then the both person saying slang languages and started vandalizing and broke all the tin which was install surrounding the land as boundary, they take some tin for sell another again they came after some time and try to **burn** a tin shed structure which is under my land but local people stop the Fire and call the police cops and patrolling van came at the incident place but they run away but passing some hours they again came and shouted and said the local people if the owner of this land did not pay us money then we both burn fire in the said land. Their intention is very clear to extort money from me and there is a chance of break law and order situation in again future the said locality.

Today when I reached in the incident place then I got information all the incident and some lady persons said that they misbehaved with them also when they try to stop them.

So I request before you to look into this matter seriously and take necessary strict action against all the both person who illegally enter in my land and destroyed all the tin boundary and illegally sold.
