beg to inform you that on 04.03.2026 at about
9:30 pm, when my son namely (1) Raja Mahata (2)
S/o Lt. Rajkumar Mahata & (3) Pappu Mahata (24) S/o
Lt. Rajkumar Mahata, resided at near Santoshi Mandir,
Santoshi Nagar, at that time, the above noted alleged
persons, started abusing them in filthy language and
when their my husband namely, Rambabu Mahata (4)
S/o Lt. Gagan Sardar, tried to interfere into the matter
they brought iron swords & iron rods and attacked
on them, my said sons namely (1) Raja Mahata &

mobile phone of my younger son namely Raja Mahata.

Sir, the house of above noted alleged persons is on
the way of our way and they have previous grudge &
enmity with us and they always create such situations
when we passed in front of their house, & intend to kill us.

So, please take necessary action against above noted
alleged persons
