I Geeta Mahato, the above noted complainant beg to
inform you that on dt. 04-03-2026 at about 4:30 pm
when I was at Maharaj Colony, alongside my husband namely
Sanjay Mahato S/o Sri Shivasaketa Mahato, ~~and~~ and
my brother-in-law namely Manoj Mahato (33) S/o Shivasaketa
Mahato & (3) Krishna Mahato (20) S/o Sri Sanjay Mahato
at that time the above noted alleged persons namely (1) Raja,
(2) Abhishek (3) Bikash, all sons of Bipin & (4) wife of Bipin
& (5) Bipin, & (6) Golu & (7) Ashish, both sons of Ranjit,
along with 05 (five) unknown persons, started abusing us in
foul language and when we protested, they attacked
on us with belt, iron rod etc. and due to this, me, my
son namely, Krishna Mahato & my brother-in-law namely
Manoj Mahato, & my husband namely, Sanjay Mahato, received
severe injury on their persons and immediately shifted
to Sreyas Distt. Hospital, and Krishna Mahato, Manoj Mahato
& we released from there after primary treatment. My husband
namely Sanjay Mahato admitted to Siliguri Distt Hospital
in serious condition.

Sir, the above noted female persons caught me by
hair and the male members namely, Raja, Abhishek, Bikram,
Bipin, Golu & Ashish, torn off my blouse & described me,
and they stolen away the Gold Magnetron of me
along with in-law, Pinki Mahato (32) w/o Sri Manoj Mahato

As the above noted alleged persons are of very
desperate & dangerous in nature & they have threatened us to
kill. So, please take necessary action against them
