In producing herewith one accused person namely MD Noor @ Ladla (M/26 years) S/o- Lt MD Jahangir of Koiladipo, Jhankar More, W/No-07, P.S- Siliguri, Dist-Darjeeling along with the following seized articles as per proper seizure list:

1. 12(Twelve) sealed plastic bottles of HIMALAYAN GOLD 60 UP country spirit each bottle containing 600 ML (Total  $600 \times 12 = 720$  Litter) amount RS-170 Each ( $12 \times 170 = 2040$ ) Marked as exhibit- A.
2. 01 (One) sealed plastic bottles of HIMALAYAN GOLD 60 UP country spirit containing 600 ML amount RS-170 taken from Exhibit - A, for examination Marked as Exhibit- A1.

With due respect and humble submission, I ASI Minhaj Al Kader, S/O- Abdul Kader of Siliguri PS under Siliguri Police Commissionerate do hereby lodge this written complain after producing herewith the above-noted seized articles to the effect that on 04.03.2026 at 22:15 hrs I received source information that one person namely MD Noor was selling liquor at Kolahati, Naya Bazar under Siliguri PS/SPC, for his wrongful gain without any documents/license. Diarized the fact in GD vide Siliguri PS GDE No- 216, dated 04.03.2026. As per your kind instruction I along with, ASI Debasish Das, ASI Subir Sen, C/- 160 Soumen Sarkar, proceeded to the PO to work out the information. At about 22.55 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid at the kolahati, Nayabazar, and detain the above noted person, who disclosed his identity as noted above. On being searched the above-noted bottles of liquor recovered from conscious and exclusive possession. Further, being asked he confessed that he is doing the business of selling since long for his wrongful gain without any valid documents/license. Then, in presence of available witnesses, I seized the above-noted articles from the PO with proper seizure list under audio, video graph, (The seizure was made in between 23:15 hrs to 23.30 hrs). As he has violated the rules and norms of Bengal Excise Act, I arrested the above noted person after observing all sorts of formalities u/s 35(3) BNSS appraising him the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely MD Noor @ Ladla (M/26 years) S/o- Lt MD Jahangir of Koiladipo, Jhankar More, W/No-07, P.S- Siliguri, Dist-Darjeeling under proper section of law and arrange for investigation.
