**Subject: Report Regarding theft in my godown.**

Respected Sir,

I Sanjay Tibrewal, s/o Biswanath Agarwal, have a unit Om Foods private Limited situated near Dabagram Industrial Estate Gate no. 4, 70 more, Uttarkanya by Lane, Fulbari, Siliguri. Today, 05/03/2026, when I opened my Unit at around 11:00 A.M., I saw that the **external lock that I put on my shutter was broken** (the shutter being closed). Another shutter which we do not use, was broken from below (from which the thieves have entered). When I went inside the godown, I saw the **items of the temple were completely scattered, my cash locker (containing around 20,000/- to 25,000/- in cash along with 35-40 silver coins) was broken and emptied, the Wi-Fi router and modem were missing with their cables cut, the cables of my two cameras (out of three) were cut with one camera remaining, and the main electric line wire was also cut.** This incident was recorded in my CCTV at **around 03:49 AM in the morning of 04/03/2026.** After this the CCTV could not record anything because the wires were cut and the main electric supply was hampered.

I also have CCTV footage of the time when the thieves have entered and one thief (there can possibly be more of them) can be seen in the clip. it is my humble request to you sir to look into the matter and try to make the maximum recovery at the earliest.
