Respected sir,

I Debopriya Lahiri daughter of Sri Ashis Chandra Lahiri, Advocate by profession, resident of Derozio Sarani, Ward No. 20 of Siliguri Municipal Corporation, Post Office & Police Station Siliguri, District Darjeeling, PIN Code 734001, in the State of West Bengal would like to inform you as follows:-

1. That a partition suit is pending between my father Asish Chandra Lahiri and his brother namely Sri Prithesh Lahiri before the Ld. Civil Judge (Senior Division) at Siliguri being Title Suit No.144/2024 where the Ld. Court has pleased to an temporary injunction order on 04/10/2024 as follows:-  
"that both the plaintiff and the defendant are directed to maintain the peaceful possession, enjoyment and their respective interest in respect of the suit property and not to change and character and/or transfer, alienate or create any third party interest in respect of the suit property till 06/11/2024".

The said solemn order of injunction has been extended time to time and the said order is still into force till 03/07/2026.

2. That in clear violation of the injunction order dated 04/10/2024 passed by the Ld. Court, my uncle along with his family members, has started changing the nature and character of the suit property by carrying out fresh interior works, including marble fitting, electrical alterations and other construction activities in the suit property, since 21/02/2026. On 27/02/2026 at about 11.20 P.M., I requested my uncle not to carry out any construction work which would violate the solemn injunction order of the Ld. Court and try to discuss the matter peacefully, my uncle without any provocation, suddenly slapped me on my face. He further kicked me on my chest and leg, and also scratched on my hand and on my breast with his nails. When my mother intervened to save me, my

aunty (kaki maa) namely Shyamoli Lahiri also scratched my mother. My uncle tried to molest my mother disrobed by pulling her nighty. Thereafter, they aggressively threatened me and my family members and loudly declared that they would falsely implicate us in a criminal case.

3. That on the same night of the incident, I dialed 100 and inform the police authority about the said occurrence. The matter was discussed with the police personnel over the phone, they were made aware of the on going violation and assault.
4. That my both the parents are senior citizens and my father is a third stage of cancer patient and also suffering from various ailments.
5. That on today i.e. 07/03/2026, morning around 10.30 a.m when I left for my work way to siliguri court my aunty abused me with filthy language and deliberately threaten me with dire consequence and said "tor sharbonash kore debo" with a clear intention to provoke me.
6. That due to the continuous harassment, hostile behaviour and intimidation by my uncle and his family members, my father is under extreme mental stress and fear. He is living in constant apprehension that my uncle and his family may cause harm to our family members. Such continuous psychological pressure has seriously affected his health.

Under the above circumstances I humbly request you to please do needful so that I and my family members get proper justice and please take necessary steps against the above noted miscreant for indulging such nefarious activities.
