inform you that on dt 05-03-2026 at about 10:30 pm,  
then I along with my brother namely, (1) Bikant Kumar Das  
(2) Arun Das (3) all sons of Lt. Bijay Das & my brother-in-law  
namely, (4) Harinder Sahai (25) S/o Lt. Ramavatar Sahai,  
his brother namely (5) Rajkanta Sahai (22) S/o Sri Brijkanta  
Sahai, were at Kachra Maata, Ward No. 4 SMC, P.O. SPS-  
Siliguri at that time, the above noted alleged persons  
started abusing us in filthy languages and when we  
protested, they brought, iron rods, Betcha, Axe, Kunda  
etc. in their hands, and all male members equipped with  
iron punch, attacked on us and we and (2) Bikant Kumar  
Das (3) Harinder Sahai (5) Rajkanta Sahai, noted above  
received severe injury, and stolen away, Silver Bracelet  
from Harinder Sahai, Gold Ring of mine, Silver chain of  
Rajkanta Sahai noted above and also damaged the  
house of Rajkanta Sahai, among the female members of our  
family namely (1) Nela Sahai W/o Sri Harinder Sahai,  
(2) Puja Sahai W/o Rajkanta Sahai, (3) Ramkali Sahai W/o  
Lt. Ramavatar Sahai, saved us from this incident, and we  
immediately shifted to Siliguri Distt. Hospital & treated ourselves  
here.
