to inform you that on St. 05.03.2026 at about 10:30  
P.M., when I along with my father namely (2) Bajjnath Sahani  
(60) S/o Lt. Ramavatas Sahani, (3) Rajnit Sahani (18) S/o Sri  
Bajjnath Sahani, my mother namely, (4) Smt. Randeel Sahani  
(45) S/o Sri Bajjnath Sahani (5) Rabi Sahani (16) S/o Sri Bajjnath  
(1) Bajrangji Tanti (27) S/o Lt. Balmukhi Tanti & (2) Smt.  
Kanchan Sahani (21) S/o Sri Bajrangji Tanti, all of Near  
Kachra Mauds, Maharaj Colony, Ward No. 4, P.S. Siliguri  
were at our house at Maharaj Colony, at that time, my
