I Arati Ghosh, W/O Gokul Ghosh, R/O South Ambedkar Colony, Pradhan Nagar, Ward No. 1, Darjeeling, Siliguri, West Bengal, Pin- 734003, I would like to draw your kind attention that while me my son namely Shubhodip Ghosh and business staff was going of shopping of holi festival the aforesaid persons namely **Ramchandra Pandit & Jeet Pandit** had come near my house at 10.00 am in the morning dated 04.03.2026 used slang and abusive languages towards me and my son namely Shubhodip Ghosh and my business staff who work at my house premises after that Ramchandra Pandit and Jeet Pandit attacked me and my son and my business staff with a deadly long and heavy and sharp steel axe in order to kill me my son and my business staff and at that very moment we are saved somehow by the local people and after that Ramchandra Pandit and Jeet Pandit become ferocious as they are unable to kill us and they threatened us by saying " holi ta par hote de tar por toder jane mere felbo" and they also threatened us that if me my son and my business staff or any of us try to lodge any complaint before the police authority will again attack and kill us to death And they are having a deep rooted criminal conspiracy as because me my son and my business staff are in great fear of death.

I therefore request you to take necessary legal action against these aforementioned persons as soon as possible before we lost our lives.
