**Subject – Written Complaint**

Sir/Madam,

I, Raj Karmakar, Son of Kamal Karmakar, resident of Boses Road, Nabadwip, Ward No. 18, Nabadwip, Nadia-741302, P.O. & P.S. Nabadwip, in the District of Nadia, presently residing at Suryasen Colony, Block-E, More Bazar-734007, P.O. Bhaktinagar, P.S. NJP, in the District of Jalpaiguri, would like to lodge a complaint stating as below:

1. The motorcycle bearing registration no. WB74BM2703 is registered in the name of my father, Kamal Karmakar. The details of the motorcycle are: Maker's Name- Honda Motorcycle and Scooter India (p) Ltd., Engine No.- JK15EW3061412, Color- Mat Marshal Green Me.
2. On 04.03.2026, I was riding the said motorcycle and had parked it near Bagajatin Colony, for approximately 20-25 mins.
3. When I returned after some time, at around 5.30 pm, I discovered that the motorcycle was missing from the place where it had been parked. I immediately searched the surrounding area and made inquiries with the people present nearby, but no one was able to provide any information regarding the whereabouts of the motorcycle.
4. With the above incidents, it appears that the motorcycle has been stolen by some unknown person/persons during the time it was parked at the said location.
5. That the motorcycle is an important means of transportation for me and my family and such incident of theft has caused me huge financial loss and immense mental trauma and agony.

6. That the incidents of theft is on the rise in the area and if such incidents are left unchecked it will cause serious loss in the area.
7. That therefore, it is prayed before you to kindly take necessary action for the recovery of my motorcycle.
