Sir,
In producing herewith one arrested accused person namely Swapan Sing (M/30 Yrs) App, S/O Nitai Sing of Ino Takimari, Gajoldoba OP, PS Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. Haywards 5000 Premium Strong Beer 09 nos. contener, Containing of 500 ML each.(4500 ML)
2. Country sprite 60 UP Style as PET GALAXY BOSS containg of 600 ML each total 13 Bottle.(7800 ML)
3. Mc Dowell's No. 1 Celebration Matured XXX RUM total 02 nos. bottles each bottle containg of 750 ML. (1500ML)
- 4) Mc Dowell's No. 1 LUXURY total 01 nos. bottles containg of 750 ML. (750ML)
- 5) Old Monk Matured XXX RUM Premium RUM total 05 bottles, containing of 375 ML each.(1875ML)
- 6) Old Monk Matured XXX RUM Premium RUM total 03 bottles, containing of 750 ML each.(2250ML)
- 7) Mc Dowell's No. 1 Superior Whisky Original 06 bottles containing of 375 ML.(2250ML)
- 8) Royal Stage Superior Whisky total 01 bottle containg of 375 (ML.375 ML)
- 9) Iconik White 1 bottle containing of 375 ML
- 10) Imperial Blue 1 bottle total 375 ML.

[Total Quantity – 22 litters 0.50ML and Total Price – Rs. 11830/-]

I, ASI. Pranab Das of Gajoldoba Out Post under Bhorer Alo PS/SPC lodged a written complainant against the above noted person to the effect that today on 01.03.2026 during mobile van duty vide Gajoldoba OP GDE No. 16, Dated: 01.03.2026 at 18:45 hrs received a source information from Takimari Bazar under Gajoldoba OP that one Pankaj Das S/O Amar Das of 2no. Takimari, Gajoldoba PS- Bhorer Alo, gathered huge amount of liquor illegally at his shop, Takimari Bazar for selling the same to the customer for his wrongful gain. Accordingly I informed to O/C Gajoldoba Out Post about the information. As per his kind instruction I along with mobile van force along with ASI. Bijay Thapa and (1) C/1528 Sankar Roy and (2) C/ 1517 Biswanath Barman all of Gajoldoba Out Post OP, Under Bhorer Alo PS/SPC proceeds to Takimari Bazar under Gajoldoba OP to work out the information. At 19.01 hrs we reached at the spot and cordoned the shop and being identified by the source our police party held raid at shop of Pankaj Das but at that time said shop owner Pankaj Das was not present in his shop. During raid I found that the above mentioned arrested accused Swapan Sing (M/30 Yrs) App, S/O Nitai Sing was present at said shop and selling liquor in the shop of Pankaj Das at Takimari Bazar and detained the person who disclosed his identity as noted above and recovered the above noted liquors from his possession / Shop. On interrogation he admitted his guilt and disclosed before police that he was selling liquor in absence of Pankaj Das. Accordingly I seized the above noted liquor from the possession of above noted accused person Swapan Sing (M/30 Yrs), after preparing proper seizure list took signature of the accused person in presence of witnesses. The seizure was made between 19.05 hrs to 19:55 hrs. Then I arrested the said person and issued Memo of arrest, Ground of arrest in presence of witnesses and informed his family member.

I therefore request you that a specific case may kindly be started against the accused person namely Swapan Sing (M/30 Yrs) App, S/O Nitai Sing of Ino Takimari, Gajoldoba OP, PS Bhorer Alo, Dist. Jalpaiguri, 2) Pankaj Das S/O Amar Das of 2no. Takimari, Gajoldoba PS- Bhorer Alo, Jpg. under proper section of law.
