Respected Sir,

With due respect, in producing herewith 01 (one) arrested accused person named Sushil Roy (M/59 years) S/o-Lt. Dhabal Chandra Roy of vill-Haricharanvita, PO-Balaram, PS-Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. 14 (fourteen) bottles of "KACHI 70 UP" country spirit (each bottle contains 300 ML), Total quantity-4200ML/4.2 L, (each bottle price Rs. 50, Total value 14*50= Rs.700-/) which was kept in a plastic made bag
2. 01(one) yellow coloured plastic made bag.

I beg to report that I, SI Chiranjit Saha, S/o-Madhab Saha of Bhorer Alo Police Station, Siliguri Police Commissionerate lodged this written complainant against one Sushil Roy (M/59 years) S/o-Lt. Dhabal Chandra Roy of vill-Haricharanvita, PO-Balaram, PS-Bhorer Alo, Dist. Jalpaiguri to the effect that today i.e. on 04/03/26 at about 20.55 hrs, I along with force while performing PC mobile van duty (This refers to Bhorer Alo PS GDE No. 145, Dated. 04/03/26) received a source information that one person was selling liquor in an open place at Dalal Road, 9 No. Colony under Bhorer Alo PS/SPC without any documents/license for his wrongful gain. As per kind instruction of my superior, myself along with PSI Wahed Kamal Pramanik, ASI Binod Ram, C/1489 Samir Barman proceeded towards Dalal Road, 9 No. Colony under Bhorer Alo PS/SPC to work out the veracity of source information. After we reached at the spot and on being identified by the source our police party held raid at Dalal Road, 9 No. Colony under Bhorer Alo PS/SPC and recovered the above noted articles from his house. During local enquiry it came to learn that he was selling the same from 01 (one) month in open market since long for his wrongful gain without any valid documents/license. In presence of available witnesses, I seized the above noted articles from his possession after preparing proper seizure list. The process of seizure was done in between 21.45 hrs to 22.00 hrs and the whole process of seizure is video-graphed through W.B. E-Sakshya App Portal. I then arrested him after maintaining all formalities. The ground of his arrest has been duly communicated with him in written.

Under the above circumstances, I would like to state that a specific case may kindly be started against the accused person namely Sushil Roy (M/59 years) S/o-Lt. Dhabal Chandra Roy of vill-Haricharanvita, PO-Balaram, PS-Bhorer Alo, Dist. Jalpaiguri under proper section of law and also to arrange for its investigation.
