8. Reasons for delay in reporting by the Complainant / Information

(i) one red colour Trolley bag styled as "Safari" containing 02 (two) paper made cartoons out of which one cartoon containing 12 bottles of "ROYSL STAG" Deluxe Whisky made in Sikkim each bottle containing 750 ml i.e total (12 x 750 ml = 09 ltrs) and another cartoon containing 12 bottles of "DOKLAM" Remix Vodka made in Sikkim each bottle containing 750 ml i.e total (12 x 750 ml = 09 ltrs) - Marked as Exhibit "A" out of which one bottle of the same taken from each cartoon as sample for examination and marked as Exhibit "A1" and "A2", (ii) one blue colour bag styled as Signature containing 48 (forty eight) bottles of "Kingfisher" Strong Premium Beer (Can Beer) made in Sikkim each bottle containing 500 ml i.e total (48 x 500 ml = 24 ltrs) - Marked as Exhibit "B" out of which one bottle of the same taken as sample and marked as Exhibit "B1" and (iii) one sky colour backpack styled as Safari containing 80 (eighty) bottles of "ROYAL BLUE" Premium Whisky made in Sikkim each bottle containing 180 ml i.e total (80 x 180 ml = 14,400 Ltrs) - Marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and marked as Exhibit "C1". (18 ltrs + 24 ltrs + 14,400 ltrs = 56.4 ltrs).

Sir,

In producing herewith two (02) accused persons namely (i) Prince Kumar (19 yrs) S/O Maya Shankar Singh of Vill- Jiyen Khurd, PS- Karja, Dist. Mujafarpur, Bihar and (ii) Jitu Kr Singh (23 yrs) S/O Akhilesh Kr Singh of Vill- Jiyen Khurd, PS- Karja, Dist. Mujaffarpur, Bihar under arrest along with following articles under proper seizure viz :- (i) one red colour Trolley bag styled as "Safari" containing 02 (two) paper made cartoons out of which one cartoon containing 12 bottles of "ROYSL STAG" Deluxe Whisky made in Sikkim each bottle containing 750 ml i,e total (12 x 750 ml = 09 ltrs) and another cartoon containing 12 bottles of "DOKLAM" Remix Vodka made in Sikkim each bottle containing 750 ml i,e total (12 x 750 ml = 09 ltrs) - Marked as Exhibit "A" out of which one bottle of the same taken from each cartoon as sample for examination and marked as Exhibit "A1" and "A2", (ii) one blue colour bag styled as Signature containing 48 (forty eight) bottles of "Kingfisher" Strong Premium Beer (Can Beer) made in Sikkim each bottle containing 500 ml i,e total (48 x 500 ml = 24 ltrs) - Marked as Exhibit "B" out of which one bottle of the same taken as sample and marked as Exhibit B1" and (iii) one sky colour backpack styled as Safari containing 80 (eighty) bottles of "ROYAL BLUE" Premium Whisky made in Sikkim each bottle containing 180 ml i,e total (80 x 180 ml = 14.400 Ltrs) - Marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and marked as Exhibit "C1". **(18 ltrs + 24 ltrs +14.400 ltrs = 56.4 ltrs)**. I, ASI Biplab Kumar Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against two arrested accused persons namely i) Prince Kumar (19 yrs) S/O Maya Shankar Singh of Vill- Jiwan Khurd, PS- Kajra, Dist. Mujafarpur, Bihar and (ii) Jitu Kr Singh (23 yrs) S/O Akhilesh Kr Singh of Vill- Jiyen Khurd, PS- Kajra, Dist. Mujaffarpur, Bihar to the effect that on 07.03.2026 art around 20.50 hrs I received a specific secret source information that two persons of Bihar are standing at Mallgauri Rly Over Bridge near Darjeeling More under PS Pradhan Nagar, Dist. Darjeeling with 03 (three) numbers of bags containing Sikkim made liquor in their possession and waiting there for a Bihar bound Bus. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 408 dated 07.03.2026 and informed the fact to you. Accordingly, as per your kind order and direction myself along with ASI Prabal Sarkar, C/1119 Tanmoy Roy all for Pradhan Nagar PS left for Mallaguri Rly Over Bridge near Darjeeling More by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Mallaguri Over Bridge, I contacted with one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over telephone and requested him to come to Mallaguri Rly Over Bridge under PS Pradhan Nagar, Dist. Darjeeling to videograph the entire process of search and seizure if required. I also informed night RT van Officer SI Gopal Ch Mandal and requested him to come to Mallaguri Rly over bridge to accompany with us.

At around 21.05 hrs. on 07.03.2026 we arrived at Mallaguri Rly over bridge and after a while night RT Van officer and the above mentioned cameraman arrived at Mallaguri Rly over Bridge and accompanied with us. I contacted with two independent witnesses namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Rajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and requested them to remain present at the spot and act as witness if required upon which they agreed. Then, I contacted with my source and being pointed by the source, I noticed that two persons were standing there with three numbers of following bags viz (i) one red colour trolley bag, (ii) one blue colour bag and one (iii) sky colour backpack in their possession. Accordingly, we cordoned the place from every corner and managed to detained both of them with above mentioned three numbers of bags in their possession. On interrogation they disclosed their name and identity as noted above and on further interrogation they disclosed that there are total 152 bottles of Sikkim made liquor are kept inside three separate bags in their possessions. Further being searched all the three above noted bags under their possession and recovered all the above noted illegal liquor from their joint possession. On demand they failed to produce any valid license/papers for selling/transporting such articles.



On further grilling, they confessed their guilt and stated that they procured the said quantities of ID liquor clandestinely from one of their suppliers of Sikkim for the purpose of selling the same in high rates to their selected customers in Bihar for their wrongful gain and also disclosed that they are waiting there for a Bihar bound Bus. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned both the detained persons namely (i) Prince Kumar (19 yrs) S/O Maya Shankar Singh of Vill- Jiyon Khurd, PS- Karja, Dist. Mujafarpur, Bihar and (ii) Jitu Kr Singh (23 yrs) S/O Akhilesh Kr Singh of Vill- Jiyon Khurd, PS- Karja, Dist. Mujaffarpur, Bihar after observing all formalities of arrest, informing them regarding the ground of their arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. The entire process of seizure and label has been made in between 23.05 hrs. to 23.55 hrs on 07.03.2026 at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS. I also informed their guardian over Mobile phone having Mobile number 8228877391 regarding arrest of above mention two accused persons.

I therefore pray before your good self that a specific case may kindly be initiated against both the arrested accused persons namely (i) Prince Kumar (19 yrs) S/O Maya Shankar Singh of Vill- Jiyon Khurd, PS- Karja, Dist. Mujafarpur, Bihar and (ii) Jitu Kr Singh (23 yrs) S/O Akhilesh Kr Singh of Vill- Jiyon Khurd, PS- Karja, Dist. Mujaffarpur, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


