Subject: Complaint for registration of FIR for commission of serious offences involving stalking, extortion, sexual harassment and criminal intimidation posing threat to life and dignity

Sir,

I, the undersigned Mina Chowdhury, daughter of Lakshman Chowdhury presently residing at Bardwan Road, Ganga Nagar, Siliguri, P.O. and P.S. Siliguri, District- Darjeeling, Permanent resident of Mahua, Mukundpur, District- Vaishali, Bihar, most respectfully submit this complaint stating that since the last two-three months, me and my family are being continuously harassed, threatened and intimidated by one **Goutam Choudhary**, Contact No. **7319111917**, who has deliberately and maliciously targeted me and my family with the intention to **exploit, humiliate, take ill favour and extort money from us**. The said Goutam Choudhary has unlawfully obtained and misused our private photographs and personal information and has been threatening me and my family with dire consequences, including public circulation of such private and obscene material, if his unlawful demands are not fulfilled. These threats have been repeatedly made with the clear intention to outrage our modesty, destroy our social reputation and coerce us into submission.

Further, it is most respectfully stated that the said Goutam Choudhary, with deliberate and malicious intention, has uploaded and circulated our photographs on Instagram and other social media platforms by creating and operating fake and anonymous accounts namely '**gautam\_f93, gzzzzz\_f93**'

solely with the object and purpose of targeting us, defaming us publicly and pressurising us to submit to his illegal demands. The said **fake accounts have been created to conceal his identity while committing such offences**. Through such online uploads, the accused has attempted to publicly shame, harass and emotionally break us in order to fulfil his ill motives, including extortion, take ill favour and exploitation. These acts have aggravated the gravity of the offence and have caused severe damage to our reputation, dignity and mental peace.

That the said Goutam Choudhary has been continuously **stalking my family specially my niece**, both directly and through his associates, by keeping surveillance over their movements, following them to and from our residence and workplace, and monitoring their daily activities. His associates have also indulged in acts of **eve-teasing and intimidation**, thereby creating a constant atmosphere of fear and insecurity. The accused has been making repeated phone calls and sending threatening messages at odd hours, including late nights and during working hours, warning us of public defamation, physical harm and social humiliation. Such continuous conduct has caused extreme mental agony, emotional trauma and psychological distress to me, my sister and our family members.

That the said Goutam Choudhary has been criminally attempted to extort money from me by putting me under fear of injury to my and my family reputation and person. Due to his repeated threats and coercive conduct, we have suffered financial loss and have been compelled to live under constant fear of further harm. That my niece are working professionals belonging to a respectable family, and the deliberate acts of the accused have severely affected our dignity, professional life and social standing. The acts of the accused are intentional, persistent and disclose a clear pattern of criminal conduct aimed at exploiting us and violating our fundamental right to live with dignity and safety. There is a real and imminent threat to me and my

family life and personal safety, as the accused and his associates have been closely following us and intimidating us repeatedly. If immediate legal action is not taken, the accused is likely to continue his criminal acts and cause further irreparable harm.

In view of the facts and circumstances stated above, I humbly request you to kindly register this complaint as an FIR under the appropriate provisions of law, take strict legal action against the alleged persons and his associates, **Trace and block the fake social media accounts** and provide us with necessary protection.
