I. SI Arun Roy (30 Yrs) S/O Bhim Chandra Roy of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, On 20.02.2026 early morning at 07.15 hrs, while I was engaged in social media monitoring duty, I came across a Facebook user named "Kattar Hindu Abhi" (profile link: <https://www.facebook.com/profile.php?id=61582791358419>) who had posted communal and provocative/abusive video comments as well as pissing and spiting to Muslim Holy pamphlet lying in the toilet pan targeting the video clip depicting members of the Muslim community. The link of the video comments is <https://www.facebook.com/share/r/1AafYK3m/>. I had gone through the profile and it could be revealed that the user continuously uploaded communal provocative post.

The circulation of such inflammatory content on social media amounts to abetment of communal violence and has the potential to incite unrest among communities within the jurisdiction of Siliguri and its surrounding areas.

Under the above circumstances, I pray that you kindly register an FIR against the Facebook user "Kattar Hindu Abhi" under proper section of law.
