Subject: Complaint regarding house breaking, criminal trespass and theft of valuable gold and diamond jewellery from my residential premises.

Respected Sir,

I, **Nagendra Mohan Prasad**, son of Late **Ram Deo Prasad**, aged about **61 years**, presently residing at **Flat No. C-3, River View Residency, 3rd Floor, Ward No. 42, under Siliguri Municipal Corporation, P.O. Salugara, P.S. Bhaktinagar, Sub-District Rajganj, District Jalpaiguri, State West Bengal - 734008**, most respectfully submit this complaint for your kind consideration and for initiation of appropriate legal action.

That I am a law-abiding citizen of India and the above-mentioned address is my permanent residential address. My identification details are as follows: **Aadhaar No. 9826 7714 1227**, Mobile No. **9933073173**, and Date of Birth **07.07.1964**.

That I am presently employed with **NHPC Limited**, in connection with the **Dibang Multipurpose Project (DMP)** situated at **Mayu Sector, Roing, P.O. Roing, District Lower Dibang Valley, State Arunachal Pradesh - 792110**, where I am associated with the **Medical Department of NHPC**. Due to the nature of my official responsibilities, I had been posted and stationed outside Siliguri for approximately the **last four months**.

That my wife **Smt. Punam Mohan** had also been away from our Siliguri residence since **04 February 2026**, as she had travelled to **Ranchi, Jharkhand**, in connection with certain family arrangements and personal engagements.

That during the said period both of us were out of station and therefore our residential premises located at **Flat No. C-3, River View Residency, Salugara, Siliguri**, remained locked and unattended.

That I have recently come to learn that **unknown miscreants have unlawfully entered my residential premises by breaking open the main entrance gate and forcibly trespassing into the house**, thereby committing house-breaking and theft.

That upon preliminary verification it appears that the said incident occurred during the **intervening night of 05.03.2026 after about 11:00 PM and before the morning of 06.03.2026 around 06:00 AM**, when the premises were completely unattended.

That the unknown offenders after illegally entering the premises **committed theft of numerous valuable gold ornaments, diamond jewellery and coins which were kept inside the house**, thereby causing substantial financial loss to me and my family.

That the stolen jewellery articles had been purchased over the years from reputed jewellery establishments including **Tanishq and Kalyan Jewellers**, and I possess the **purchase bills and supporting documents relating to the said jewellery articles**.

That the details of the stolen articles including their **description, approximate weight and purchase value are mentioned below**, which I have compiled from the purchase records and bills in my possession.

Additional Jewellery Articles (Marriage / Shadi Ornaments)

It is further submitted that apart from the jewellery articles mentioned above which were purchased from **Tanishq and Kalyan Jewellers**, certain additional gold ornaments forming part of the **customary marriage jewellery (Shadi ke gehne)** belonging to my family were also kept inside the said premises and were stolen during the said incident.

The said articles include the following items:

It is respectfully stated that the **exact weight and value of the above marriage jewellery articles cannot be immediately ascertained**, as these items were acquired as part of **family and matrimonial customs**, and the purchase bills or precise valuation details are presently not readily available.

However, the said articles were valuable gold ornaments and were kept along with the other jewellery articles inside the residential premises.

That it is specifically stated that the **value mentioned above is based upon the original purchase bills and the value reflected therein at the time of purchase**, and therefore represents the **purchase value on the respective dates of purchase**, and not the present market value of the said jewellery articles.

That I further state that the offenders have committed the said act by **breaking open the main entrance gate of my residence and unlawfully entering the premises**, thereby clearly committing offences of **house-breaking, criminal trespass and theft**.

That I have **strong suspicion upon certain persons including the security guards of the residential society and certain labourers who had previously carried out work inside my premises a few months ago**, as they were aware of the internal layout of the premises and the fact that the house remained unoccupied for a considerable period. I possess their names and contact numbers and I am willing to provide the same to the Investigating Officer during the course of investigation.

That the above incident has caused severe financial loss and mental distress to me and my family.

Therefore, I most respectfully request your good office to kindly **register a formal FIR against the unknown offenders for offences of house breaking, criminal trespass and theft**, conduct a thorough investigation into the matter, identify and apprehend the culprits involved, and take appropriate legal action in accordance with law.

I further request that necessary steps be taken to **trace and recover the stolen jewellery articles at the earliest possible opportunity**.

I assure my full cooperation with the investigation and shall produce all purchase bills, documents and other supporting materials whenever required by the investigating authorities.
