This is to inform you that my sister Ms. Mitra Saha was on her way to office, as she crossed Model Town at around 2.55 PM, Iskon Mandir Road, a speeding biker from behind crashed onto her scooty. The impact of crash was severe, which caused the scooty as well as the bike to fall on the main road and my sister had to bear broken left wrist, back and other injuries. Had it not been for the helmet, her skull would have also broken due to severity of the impact. Her broken wrist and other injuries has caused huge trauma and pain to my sister and
