Respected Sir,

I, SRI KETAN KUMAR GOYEL, S/O- Sri Mahavir Prasad Goyel, permanent resident of M.G. Marg, P.S- Sadar Thana, Gangtok, Sikkim, presently residing at Ashram Para, Ward No. 14, P.S.- Siliguri, Dist. Darjeeling (W.B.), do hereby lodge a written complaint on an incident which was occurred with me on 08.03.2026 on approx 11- 11.30 p.m. at night when I was coming back towards my home on my car, at a U-Turn in front of "Makhan Bhog" suddenly one scooty rider hit my car from the right side & broke my car's right mirror. I asked him to stop and the scooty rider stopped and I asked him to drive carefully. Suddenly another unknown scooty rider came from no-where and started to abuse me with filthy languages and suddenly slapped me on my face and jumped on my car's bonnet and started to punch the windshield of my car. The said scooty rider (namely Ankit Chowdhury, later on I came to know his name) was in drunken condition and was shouting & telling me that he is an influential 'NETA' of the local area and he will teach me a lesson today. The local pedestrians then came in support of me and the said Ankit Chowdhury started to go with his scooty.

After turning back my car, probably within few meters, again I saw the said Ankit, he stopped my car, in an intoxicated condition, dragged me out of my car and started to beat me brutally. Within few minutes, 20-30 another man (probably Ankit Chowdhury's associates) gathered there and joined Ankit and dragged me through the road and started to kick me and was shouting inhumanly that today he will teach me a lesson to set up a landmark for all the drivers. That the said Ankit was in a very bad drunken condition and was continuously threatening me that today he will kill me. I got serious injuries on my chest, right hand & neck. Then they started to vandalize my car, broke all the glass portions, dashboard, android system & the outer body part of my car. Suddenly one of the associates of Ankit took out my MacBook/Laptop from inside of my car and went away from there. I was in a very bad condition lying on road, in pain, crying for help. Few pedestrians tried to come for my help, but did not dare to come close to me.

After some time, a police van came & rescued me & took me to Panitanki TOP, but the said Ankit & his associates still were chasing the police van on the way to Panitanki Town Out-Post. Later on, on the very same night i.e., on 08.03.2026, I came to know one case has been registered against me & police on the next day forwarded me before the Id. ACJM, Siliguri. On hearing, the Id. Court was pleased to enlarge me on bail. I thereafter, came before You & lodging this written complaint against the said Ankit Chowdhury & his associates.

Sir, I am now in a very bad health condition and I am in fear that the said Ankit Chowdhury & his associates may again attack me somehow. They are very dangerous & desperate in nature & they have no regard in law. Kindly take necessary lawful action in this regard.
